

# **NOTIFICATION**

## **CATEGORY 'B' Admissions**

### **(Into B.E/B.Tech & B.Pharmacy courses for the year 2012-2013)**

In continuation of the notification displayed on this website dated: 13.09.2012. It is hereby informed to the Managements of Private Unaided Minority & Non Minority Engineering & Pharmacy colleges that; to speed up the approval process of 'B' category admissions APSICHE made an arrangement with CGG to facilitate the managements to upload the list of admitted candidates in the web portal apart from submitting hard copies directly to the Secretary APSICHE.

- The last date for submission of the admission lists (Category 'B' seat) to the Competent Authority (APSICHE) is as **20<sup>th</sup> November, 2012.**

The managements of private un-aided Non-Minority and Minority institutions are informed to:

- (i) Upload the list of admitted candidates in [www.apsche.cgg.gov.in](http://www.apsche.cgg.gov.in) in the respective college logins in the proforma prescribed in the ANNEXURE-II.
- (ii) To submit the hard copies of admitted list of candidates along with the following documents.
  - a) Original Paper Notification issued for Category 'B' seats in respect of Non-Minority / Minority college.
  - b) Lists of Applicants to Category 'B' seats with name, address, EAMCET-12 Rank, percentage of aggregate marks in Intermediate examination.
  - c) Merit list of the eligible applicants in descending order of ranks & descending order of Percentage of marks (to those who have not secured EAMCET rank), admissions shall be made following the merit lists.
  - d) Copy of Intermediate & 10<sup>th</sup> class Marks Memo, copy of transfer certificate and copy of community certificate.

The admission list as shown in the **Annexure-I** shall be submitted separately for Engineering /Pharmacy programmes. It is also informed that late submission beyond the cut-off date mentioned above will not be permitted.

**Note:** The Colleges who made irregular admissions for the academic year 2011-2012 and paid penalty of Rs.13,000/- per seat for ratification are hereby informed not to fill up equal no of seats in Cat 'B' admissions in that respective branch as per undertaking given by said management, who obtained G.O.RT's per ratification.

- The seats shall be filled following the rules of admissions prescribed in G.O.Ms.No.74 & amendment in G.O.Ms.No.93 & 47 (for Non Minority Institutions) & G.O.Ms.No.75 & amendment in G.O.Ms.No.94 & 48 (for Minority Institutions).
- **Eligibility Criteria for admission (Cat 'B' seats):**
  - 50% marks in aggregate/group subjects in the qualifying examination or CGPA equivalent to 5 on scale of 10 for **NRI candidates**
  - AIEEE Rank and 45% marks in group subjects in the qualifying examination for **other State candidates**
  - **Vacant seats or unfilled seats** in the above categories shall be filled with candidates in the following order
    - EAMCET rank with 45% marks in group subjects in qualifying examination
    - 50% marks in aggregate/group subjects in the qualifying examination.

**Foreign Nationals are not eligible for admission.**

**NIOS/APOS passed candidates are not eligible for B.Pharmacy course.**

No proposals submitted after the stipulated date i.e., as **20<sup>th</sup> November, 2012** shall be accepted under any circumstances, and the College Management will be held responsible for the ratification of the students admissions.
