GUIDELINES FOR ADMISSION INTO 3 YEAR / 5 YEAR LL.B. /B.L & LL.M COURSES UNDER CATEGORY 'B'SEATS FOR THE ACADEMIC YEAR 2012 -2013

A. Important Note:

All the Admissions shall be made in accordance with the provisions of the relevant G.O.s viz., G.O.Ms. No.64, Dt: 26.05.2006, G.O. Ms. No. 250, Dt: 27.10.2008, G.O. Ms. No. 31, Dt: 18.03.2009, G.O. Ms. No. 116, Dt: 07.08.2007 as the case may be and their subsequent amendments.

B. <u>ESSENTIAL ELIGIBILITY CONDITIONS [for 3 Yr/ 5 Yr LL.B Course]</u>

1. Candidate must be an Indian National.

2. Educational Qualifications:

- i. Any degree from a recognised University in India in 10+2+3 for 3 yr LL.B/B.L Degree and 10+2 pattern for 5 year LL.B./B.L Degree.
- ii. Candidate should secure the following percentage of marks in the Qualifying Examination.

45% - OC/BC 40% - SC / ST

- iii. Candidates who have secured less than the prescribed percentage but have secured the same percentage or more in aggregate in any PG Degree or B.Ed. are also eligible for admission into 3 year LL.B. course.
- iv. Candidates who have obtained (10+2) or Degree by single sitting either through regular or private or correspondence mode are not eligible.
- v. Candidates, who obtained (10+2) or Degree through Open University system without having any basic qualification are not eligible.
- 3. Vacant seats may be filled with eligible candidates including those who secured not less than 45% marks in aggregate in the qualifying examination duly ensuring merit and transparency.

C. <u>ESSENTIAL ELIGIBILITY CONDITIONS</u> [for LL.M. Course]

1. Candidate must be an Indian National.

2. Educational Qualifications:

- i. The candidate must have passed 3 Yr/ 5 Yr LL.B./ B.L. from a recognised University in India.
- ii. Candidate should secure the following percentage of marks in the Qualifying Examination.

50% - OC/BC 45% - SC / ST

- iii. Vacant seats may be filled with the eligible candidates including those securing not less than 50% marks in aggregate in the qualifying examination duly ensuring merit and transparency.
