**ADVERTISEMENT**

Applications are invited from Female/ Male Citizen of India for recruitment of the following posts of Sub-Inspector against **Civil Police; IRBN & Telecommunication (WT)** under Arunachal Pradesh Police in the pay band of PB-2 of Rs. 9300-34,800 + Grade pay Rs.4200/- P.M. The details are given herein after.

**1. NO. OF POSTS:-**

**i. Sub-Inspector (GD):- Civil Police – 51 posts & IRBN – 41 posts.**

Out of 51 posts of Civil Police, 28 posts are exclusively reserved for the domicile APST candidates of Tirap, Changlang & Longding districts. The breakup of distribution of posts among the three districts as per ratio of APST population of the district and reservation policy is as under:

**2. ELIGIBLE AGE:-** The age of candidate should be between **20 to 25** years as on **01-01-2013**. Relaxation of upper age limit for APST & SC/ST candidates is given up to maximum of 5 (five) years.

*The candidates should be free from physical deformity/infirmity like squint eye, knock knee, bow leg, dismembered fingers and any other physical deformity/infirmity which is likely to impede performance of active duty in police force. The candidates with such deformity/infirmity will be rejected during the Physical Standard Test/Medical examination.*

*NOTE: As the police force is secular in nature and have strict code of police uniform, any indecent marks such as tattoo, body piercing etc., are not desirable in the force. Hence applicants are expected to take corrective measures before applying.*

**6. DATE OF RECRUITMENT:-**

- i) **Receipt of applications:** Dully filled up application form accompanied with attested copies of certificates of educational qualification, age proof as per school Certificate/Admit card/Birth Registration Certificate, Caste/Tribe certificate, Permanent Residential Certificate (PRC) of the district, 04 (four) nos. recent passport size photographs (one affixed on the application form at space provided and 03 (three) nos. (Securely enclosed in an envelope) with self signature on backside and self addressed reply envelop affixed with postage stamp of Rs. 5/- will be received **W.E.F. 08-12-2012** at P.H.Q Itanagar. A treasury challan of Rs. 15/- for APST candidates and Rs.60/- for General candidates in favour of Asstt Inspector General of Police (E), PHQ, Itanagar under **Head of Account "0055" Police**, should be also enclosed.  
**The application forms can either be sent by ordinary post or directly submitted by hand at P.H.Q Itanagar in all working days.**
- ii) **Last date of receipt of applications: "28s-12-2012"** No application shall be accepted after expiry of last date of submission.
- iii) **Admit Cards/Call Letter:** Admit Cards/Call Letter will be issued to eligible candidates after preliminary scrutiny of application forms. *Candidates whose application forms are found incomplete in any form, under age/overage and non-submission of required documents will be summarily rejected during preliminary scrutiny of application forms.*
- iv) **Scrutiny of documents and Physical measurement:** Scrutiny of the documents and measurement of physical standard shall be carried out at Police Training Centre, Banderdewa for all candidates. The date and time will be notified in the admit card/call letter.  
**NB: The candidates will be required to bring along the original documents/ testimonials submitted along with application form at the time of scrutiny of documents for verification & authentication. The candidature shall be rejected on non-production of original documents during scrutiny.**
- v) **Physical efficiency tests:** The Physical efficiency tests shall be conducted at Police Training Centre, Banderdewa for all candidates. The date and time will be notified in the admit card/call letter.
- vi) **Written Examination:** The written examination will be tentatively conducted on 13<sup>th</sup> January 2013. The exact date, time and venue will be notified in the call latter.

**7. SELECTION PROCEDURE:-**

- i) **PHYSICAL EFFICIENCY TEST:** - The sort listed candidates whose application /documents are found in order in all respect and who are found fit in physical measurement will be put through physical efficiency test in the following events.

**NB: The physical efficiency test will be of qualifying in nature. However, candidates who do not qualify the minimum qualifying standard in any of the above events shall be treated disqualified for the next level/stage.**

- ii) **WRITTEN EXAMINATION:** - The eligible candidates of physical efficiency test will be put through written test in one paper which will have three sections covering General English, General Knowledge and Elementary mathematics of 100 marks each. The place of written examination will be announced by the Chairman of the Recruitment Centre.

**NB: - 1. The written examination will be of multiple choice objective types on OMR format.**

**2. The minimum aggregate marks in written examination will be 45% in aggregate.**

- iii) **INTERVIEW:** - The candidates scoring more marks in written test in descending order of merit but not exceeding 3 times of the actual vacancy will be called for interview/viva voce. The date, time and place will be announced later. The maximum marks for interview will be 40.
- iv) **MERIT LIST:** - The final merit list of the selected candidates will be made on the basis of overall marks secured in written test and interview put together. The merit list of the reserved post against Tirap, Changlang and Longding districts will be prepared separately from the combined merit list. The merit list of Telecommunication shall also be separate.
- v) **MEDICAL EXAMINATION/CHARACTER & ANTECEDENT VERIFICATION:** - Appointment of provisionally selected candidates shall be subject to successful medical examination conducted by medical board and positive verification of character & antecedents.
- vi) **APPOINTMENT:** -The selected candidates shall be appointed against the respective vacancies on the basis of descending order of merit cum choice in **Civil Police and IRBN** respectively.

***The candidates who are appointed against the vacancies of IRBN are liable to be deployed anywhere in the country.***

Though police department shall arrange first aid at recruitment center for emergencies, the department shall not be responsible for any personal damage/injury to the candidates during the recruitment process/physical endurance efficiency test.

No TA/DA will be admitted to the candidates for attending in the recruitment process. The candidates shall have to bear their own expenses and arrange accommodations on their own during the recruitment process.
