### **Terms and Conditions of Engagement for Yoga Teacher**

1. The engagement of Yoga Teacher, is provisional, for a period of one year only at present likely to be extended further on mutually agreed terms and conditions subject to review of performance and results etc.
2. Candidates should be certified from a recognized yoga institute acceptable to the Bank.
3. **Remuneration**
  - a. Up to Rs. 25000/- per month, lump sum, inclusive all as a total package.
  - b. No other pay, salary, perks, allowances, compensation etc. are payable.
  - c. No other benefits like Medical/ Hospitalization / LFC, LTC/ DA/ TA/ PF/ Gratuity/ Pension etc. are admissible.
  - d. TDS as per IT Rules, if applicable, would be deducted from remuneration.
4. **Engagement**

Presently Yoga Teacher will be engaged at Head Office of Bank at Begusarai. They will have to impart training in Yoga to staff members of Bank at Head Office as well as other staff members posted at nine Districts as per schedule given by Bank.
5. **Accommodation**

Yoga Teacher will be required to make his own arrangements for stay at the place of posting.
6. **Leave Rules**

He will be eligible for following kinds of leave in one year as per rules

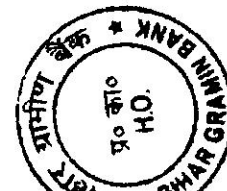
  - a. Casual Leave 12 days on full emoluments (1 day's casual leave for every month of service during first year of contract). Not more than 4 days casual leave may be availed of at any one time. Casual Leave not availed of in any year will lapse.
7. **Duties and Responsibilities:**
  - i. Maintaining discipline, decorum, decency & punctuality.
  - ii. Yoga Teacher will always have to keep in mind while discharging their duty the objectives of appointment of Yoga Teacher.
  - iii. Office-hours, duty-hours, holidays etc. would be as per Bank's requirement.
8. **Termination of Contract**

He will be not an employee of the Bank. This engagement is purely temporary, provisional and liable to be terminated at the sole discretion of Management of the Bank with one month's notice or payment of remuneration for one month in lieu thereof during the contract period without assigning any reason. 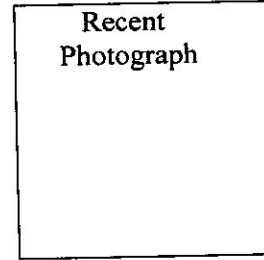
