4. **Above tenure may be extendable.** In any case, the same shall be co-terminus with the Project or till such time the job performed by him/her in the project exists whichever is earlier. With respect of Research Intern, the maximum tenure is 2 years from the date of joining and is not extendable under any circumstances. Performance of the Intern will be reviewed every six month. In case, the performance is not satisfactory, the internship will be terminated with one month's notice or one month's stipend in lieu thereof. During the Internship period, the intern would be free to appear for NET/GATE and secure regular fellowship for doing Ph.D
