Relaxations:

- 8. No upper age limit for CSIR department candidates.
- 9. Upper age limit is relaxable upto 5 years for the regular employees working in Government Departments, autonomous Bodies and Public Sector Undertakings.
- 10. Upper age limit is relaxable by 5 years in the case of SC/ST and by 3 years in the case of OBC candidates for the posts, which are reserved, for the respective categories. (Current year's certificate in the central government prescribed format is to be enclosed) Relaxation in upper age limit for Persons with Disabilities (PWD) and Ex-servicemen will be applicable as per Govt. of India rules.
