- Bank may change vacancies position as per requirement.
- There shall be reservation of 3% for physically challenged and 20% for ex-servicemen within the total vacancies.
- There shall be 4.5% sub quota reservation for minorities within 27% reservation of OBC as per Government guidelines.

**B) The Candidates who have worked as a Safai Karmachari or sub-staff on temporary or as a casual worker in branches/ Offices are allowed to participate in this process those subject to fulfill the criteria.**

- a) Such temporary/casual worker should have been engaged in sub-ordinate cadre (including as Safai Karmachari ) and have put in a minimum 45 days service during a continuous period of 12 months.
- b) The age of the candidate should have been between 18 to 26 (relaxable in eligible categories as per rules) when they were initially engaged as temporary/casual worker.
- c) The age of the candidate as on 09.08.2012 should not have been more than 45 years, irrespective of category (i.e., SC/ST/OBC/GEN).
- d) The candidate should produce satisfactory proof as prescribed by Bank in support of his/her claim of having worked with the bank on temporary/casual basis for a minimum 45 days in a continuous period of 12 months.
- e) The Registration for employment with Employment Exchange by the candidate is preferred, but not essential. Accordingly, the candidates having valid Registration with Employment Exchanges should attach the duly attested cards/proof to this effect.
- f) In case any of the candidate had hitherto filled cases in Courts/ALC/RLC/CGIT etc. seeking absorption in permanent employment in the Bank and such cases are still pending for final disposal, such candidates should willingly and unconditionally withdraw such cases filed by them before different fora prior to applying for participating in the Recruitment Process in which they are so allowed to participate in terms of this Settlement for the post of 'Safai Karmachari-cum-sub-staff' and/or 'Sub-staff', subject to otherwise being eligible as per the eligibility criteria prescribed for respective post, and a declaration to this effect should be given along with an undertaking that he/she would abide by the results of the recruitment process.

**2) Educational Qualification:**

- a) Minimum Eighth Standard pass or equivalent. Candidates with higher qualification shall have no concession in the service and cannot claim any further grade on the basis of his/her higher qualification. Successful candidates will be appointed for the post of Safai Karmachari cum sub-staff and/or sub-staff only irrespective of his/her higher educational qualification.

**3) General conditions :**

- I. Selected Candidates will be posted any branch/office under the region and they can be transferred any other branch/office as per management exigencies.
- II. Selected Candidates will be on Probation for the period of 6 months.
- III. Salary will paid as per Bank rules.
- IV. Candidate may apply for both the post in one application form.
- V. Candidate has to attach a certified copies of educational qualification, caste certificate, physically challenged certificate, ex-servicemen certificates and

employment exchange registration card, if registered. (attested photo copies should be enclosed).

- VI. Incomplete applications will not be considered.
- VII. Eligible candidates will be called for interview. If candidate fail to attend such interview no further correspondence will be considered or entertained.
- VIII. If it is found that a candidate given incorrect or wrong information,his /her candidature will be stands cancelled automatically.
