## II. Scale of Pay

#### III. Age

Age as on 31 Jan 2013 shall not exceed 35 years, relaxable by 3 years for OBC and 5 years for SC/ST, 10 years for Persons with Disabilities (PWD) and 45 years or the period of military service plus three years in the case of Ex-servicemen. Further relaxation of age will be granted in deserving cases who have experience of working in Shipyards.

### IV. Method of Selection

For all posts the selection process will be held at Cochin Shipyard Limited, Kochi on the dates decided by the Shipyard. Request for change in venue/dates of tests/interview will not be entertained. The method of selection will include a Written/Practical Test/Personal interview.

## V. Conditions

#### a) Reservation

- (i) Government of India Directives on reservation applicable for Scheduled caste (SC)/ Scheduled Tribe (ST)/ Other Backward Class (OBC)/ Persons with Disabilities (PWD) / Ex-Servicemen (ESM) candidates will apply and be strictly followed.
- (ii) From the posts notified at Sl No. A1 & A2 and B1 to B 19, twelve vacancies are reserved for Persons with Disabilities (Visually Handicapped/Hearing Handicapped / Orthopaedically Handicapped) category. The physical requirement for posts include ST, S, W, BN, L, SE, KC, MF, H, RW and PP (ST-Standing, S-Sitting, W-Walking, BN-Bending, L-Lifting, SE-Seeing, KC-Kneeling & Crouching, MF-Manipulating with Fingers, H-Hearing, RW-Read & Writing, PP-Pulling and Pushing)
- (iii) In the case of Persons with Disabilities the degree of disability should be minimum of 40%. The candidate should possess latest Certificate to this effect in the prescribed format issued by an authorised Medical Board constituted by the Government of India / State Government.
- (iv) Reservation of posts for Ex-servicemen 14.5% in the case of posts at Sl No. A.1 to A2 and B.1 to B.6 and 24.5% in the case of posts at Sl no. B.7 to B.19 will apply.

#### b) Qualification

- (i) Those candidates having qualifications equivalent to any of the prescribed qualifications should enclose equivalency certificate issued by the competent authority along with print out of their online application and without such certificate candidature will not be considered.
- (ii) Relaxed standards in qualification requirement (55% of marks and above in qualifying examination wherever applicable) will be followed in the case of SC/ST candidates, provided they satisfy all other requirements.
- (iii) For the post of Crane Operator (Electrical) at Sl No. B.10 the requirement of National Apprenticeship Certificate will be relaxed in the case of candidates having more than 5 years experience in operating EOT cranes in a Shipyard or Heavy Engineering Company. For the post Crane Operator (Diesel) at Sl No. B.15, in the absence of sufficient number of candidates with National Trade Certificate in Fitter or Mechanic (Diesel), Ex-Servicemen possessing National Trade Certificate with five years experience in operating Diesel Cranes in a Shipyard or Heavy Engineering Company will also be considered.

## c) Experience

- (i) Post qualification experience only will be considered. Period of experience will be reckoned as on 31 Jan 2013. The period of Apprenticeship Training in the relevant trade under the Apprentices Act 1961, will be treated as experience. Period of Advanced/ADS training in Cochin Shipyard will also be treated as experience for determining eligibility. Experience Certificates obtained from Shipyards/Heavy Engineering Companies registered under the Companies Act 1956 or Foreign Shipyards/Companies of equivalent status will only be considered for short listing.
- (ii) Period of experience stipulated for posts at B1 to B2 may be relaxed by a maximum of 2 years in the event of non availability of reserved candidates with prescribed years of experience.
- (iii) For the post of Crane Operator (Electrical) at S1 No. B.10 the experience requirement will be relaxed in the case of candidates having experience in operating EOT cranes in a Shipyard or Heavy Engineering Company provided they meet requirements.

### d)General

- (i) Depending upon number of online applications received for all the posts, Shipyard reserves the right to stipulate a higher cut off mark than the minimum eligibility marks stipulated in the qualifying examinations and accordingly short list candidates for consideration for selection.
- (ii) Candidates should produce original certificates for verification at the time of test/interview and in case of failure to produce the original certificates, the candidature will be rejected. Candidates should satisfy themselves that they fulfill the requirements as per the notification before submitting application for a post through online. If at any stage, it is found that any information furnished is false / incorrect or the candidate does not satisfy the eligibility requirements, the candidature is liable to be cancelled / rejected.
- (iii) SC/ST/PWD candidates appearing for written/practical test/ interview shall be reimbursed to & fro second class rail /bus fare by the shortest route from the mailing address mentioned in their online application to Cochin Shipyard Ltd, Kochi subject to production of train/bus ticket and as per rules.
- (iv) No correspondence regarding the rejection of application in case of ineligibility will be entertained.
- (v) Shipyard reserves the right to conduct additional examination/skill test or call for any additional documentary evidence in support of qualification and experience claimed by the candidates in their online application.
- (vi) Those who are working in Government Departments or Public Sector Organisations should produce "No Objection Certificate" from the employer at the time of test/interview failing which candidature will be cancelled/ rejected.

- (vii) Submission of application through online and Issue of admit card for test/interview shall not confer any right to the candidate of acceptance of candidature or cannot be construed as an acknowledgement of fulfilling the eligibility criterion.
- (viii) Appointment of selected candidates will be subject to verification of character and antecedents and verification of caste certificates if applicable.
- (ix) Applicants should be of sound health and satisfy the medical fitness standards as fixed by the company. The selected candidates should undergo a medical examination in the hospitals as prescribed by the company and medical fitness of all candidates are further subject to certification by the company medical officer.
