No individual intimation will be sent. List of selected candidates will be displayed in the University Website: <http://ntruhs.ap.nic.in> on 22-10-2012 and in the University Notice Board. The provisional selection intimations to the selected candidates will be sent by post.

Further, the details of colleges and the available seats in the above courses will be displayed on the University Website and University notice board two days before the counseling.

The registration fee of Rs,4,600/- for each course shall be paid by the candidate at the time of admission through DD drawn in favour of the Registrar, Dr. NTR UHS, Vijayawada at the respective college only where he/she is admitted.

Mere attending the counseling for exercising options does not confer right for a seat. If necessary, candidates have to stay for one more day.
