

#### **Pharmaceutics**

The Pharmaceutics laboratories for Physical Pharmacy, Dispensing & Hospital Pharmacy, Pharmaceutical Engineering, Pharmaceutical Technology, Cosmetic Technology, etc., are fully equipped with state-of-the-art equipments such as - Electro lab dissolution rate test apparatus, tablet compression mechines, tray driers, all purpose equipment and many more to impart industry oriented skills in manufacturing of formulations.





#### Pharmacology

#### Pharmaceutical analysis

The Pharmaceutical analysis laboratories with central instrumentation facilities for Pharmaceutical Analysis, Chemical Analysis,, Electro Chemical Analysis, Chromatographic methods of Analysis, Instrumental Methods of Analysis, Advanced Instrumental Methods of Analysis, are equipped with high end instruments like Shimadzu HPLC with PDA Detector, UV Visible Spectrophotometer, Florimeter, Flame Photometer etc.,

The Pharmacology laboratories for APHE, Pharmacology, Pharmacological Methods of Screening, Advanced Systemic Pharmacology, Bioassays & Screening Methods are fully equipped with all essential instruments like Actophotometer, Rotarod, Poleclimbing Apparatus, Analgesiometer, Convulsiometer, Plethsmograph, Sherrington drums with Perspex bath assembly, Centrifuge, Metabolic cages, etc.





#### Pharmaceutical chemistry

The Pharmaceutical chemistry laboratories for Pharmaceutical Organic Chemistry, Medicinal Chemistry, Advanced Medicinal Chemistry, Pharmaceutical Inorganic Chemistry, Medicinal Biochemistry, Chemistry of Bulk Drugs, Chemistry of Natural Products are fully equipped with state-of-the-art equipments like Rotary Evaporator, Microwave Oven, Digital Melting Point Apparatus, Muffle Furnace, Reflux flask with condenser etc.

#### Pharmacognosy and Phytochemistry

The Pharmacognosy and Phytochemistry laboratories for Phytomedicines, Chemistry of Natural Products, Herbal Drug Technology are equipped with equipments of industrial significance such as I R Moisture Balance, Digital Colony Counter, Projection Microscope, Zone Reader, Laminar Air Flow, Florimeter, Autoclave, Soxhlet Apparatus, TLC Kit, Clevenger's Apparatus, BOD Incubator, Hot Air Oven, Microscopes, Binocular and Trinocular Microscopes etc.





#### Pharmaceutical Biotechnology

Pharmaceutical Biotechnology laboratory is provided with modern facilities with aseptic unit for the labs like Pharmaceutical Microbiology, Disinfection Sterilization and Immunology, Biological Pharmacy and Pharmaceutical Biotechnology for the UG program with latest equipments like Laminar Airflow, BOD Incubator, Orbital Shaker Incubator, Gel Electrophoresis, Tissue Culture Station, Rheometer, Viscometer, Sonicator, Respinometer, Water Bath Incubator etc.

#### **Central Library:**

A fully Air Conditioned central library popularly known as Knowledge Resource Centre is provided with all modern facilities like Internet, Digital Library and E-learning centre. The Library has a rich collection of 11.60 lakhs books and e-learning resources, periodicals, national and international journals. It is provided with Info-Net service that facilitates online access to e-books and e-journals.

#### World Class Data Centre:

GITAM has a Data Centre (Central Computing Facility) housing a Super Computer capable of delivering 1.5 Teraflops (1.5 Trillion Floating Point Operations per second), an enterprise-class Unified Storage of 70 Terabytes (expandable to one petabyte – 1000 terabytes), 60 high-end servers most of which are virtualized with VMware – Enterprise+ with implementation of Cloud Computing. The network at GITAM is a world-class network with 10G backbone and a sophisticated high-end Wi-fi network covering the entire campuses, both at Visakhapatnam and Hyderabad, which is capable of streaming live and on-demand video lectures to thousands of students. The wired and securely managed Wi-fi networks together are capable of serving up to 15,000 simultaneous clients. The network is connected to the Internet at a blazing speed of 1Gbps (1000 Mbps).

#### **Campus Amenities:**

The day-to-day needs of the student community are well taken care of by the amenities provided on the campus like day care health centre, Union Bank of India and Indian Bank with ATM, Post Office, Book Store, Photo Studio, Travel Agency, Beauty Parlour, Sub-Way and Food Courts.

#### 1.3. How to Apply

Candidates can apply in any one of the following methods:

- i) Applications can be downloaded from the website www.gitam.edu
- ii) Application can also be obtained from the office of the Principal, GIP on payment of Rs.100/- in person, or can be obtained by post by sending a request along with a DD for Rs.100/- drawn in favor of GITAM Institute of Pharmacy, payable at Visakhapatnam.
- iii) The filled-in application along with the Demand Draft for Rs. 600/- drawn in favor of GITAM Institute of Pharmacy, payable at Visakhapatnam on any scheduled bank, along with the copies of the certificates of qualifying examinations and other relevant certificates should be sent to the Principal, GITAM Institute of Pharmacy, GITAM UNIVERSITY, Gandhi Nagar Campus, Rushikonda, Visakhapatnam- 530 045, Andhra Pradesh, INDIA on or before the last date for submission of application.

#### 1.4. GIPAT-2012 TEST CENTRES

#### Admission Tests for GIPAT 2012: GIPAT (UG) 2012 / GIPAT (PG) 2012

i) The written test for admission to the B. Pharm & M. Pharm programme will be conducted at the following centres all over India depending upon the number of applications received for each centre. Candidates should indicate three different test centres in order of preference.

The University reserves the right to cancel any test centre. In case of cancellation of any centre(s) for any reason, the candidates who have opted for such centre(s) will be accommodated in an alternate test centre. The final list of test centres and venues will be decided only after the cut off date of receipt of applications. The details will be displayed on the website <u>www.gitam.edu</u>.

#### 1.5. About GIPAT - 2012

- i) Candidates should arrive at the test centre one hour before the scheduled time.
- ii) All the questions will be in English language only. All the questions will be of multiple choice. Instructions for answering the questions need to be followed scrupulously.
- iii) The test result will be announced within one month from the date of completion of GIPAT-2012.

#### 1.6. Merit List for Admissions

A candidate who has appeared for GIPAT-2012 will be eligible for admission only if he/she gets the required minimum marks in the qualifying examination, as per the eligibility criteria subject to the rule of reservation as per UGC guidelines / norms as applicable to the university. The merit position of the candidate for admission will be based on the score obtained in the admission test (GIPAT 2012).

#### 1.7. Direct Admission to Board Toppers

First rank candidates of all central and state boards in India for the year 2012 will be given direct admission to the B. Pharmacy programme, irrespective of their GIPAT-2012/GAT (UGT) 2012 score as per the eligibility criteria mentioned above. However they have to submit the application as prescribed.

#### 2.2 Admission Criteria:

#### The following are the criteria for admission to B. Pharmacy Programme:

i) Pass in 10+2/12<sup>th</sup> examination in Science stream from a recognized Central / State Board or its equivalent either in 2012 or 2011, subject to securing the following percentage of marks :

<u>A minimum of 60% marks in the group aggregate of Physics, Chemistry & Mathematics / Biology and 1<sup>st</sup> Class or its equivalent grade in the qualifying examination in a single attempt.</u>

- Candidate should indicate three different test centres in order of preference in the application for consideration by the University.
