1. QUALIFICATION AND EXPERIENCE REQUIREMENT

1.1. Medical Superintendent/Senior Medical Officer (Medicine) (Grade IV/III)

Qualification requirement:

<u>For Grade-IV post</u>: MBBS + PG Degree in **Medicine** + 3 years post qualification relevant experience.

<u>For Grade-III post</u>: MBBS + PG Degree/PG Diploma in **Medicine** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to manage all medicine cases attending OPD and medical emergencies
- Must have good knowledge in managing patients in ICU.
- Knowledge in Echocardiography and stress test will be preferred.
- Should be able to manage cases attending emergency room when required
- Should be able to perform duties as a General Duty Medical Officer

1.2. Medical Superintendent/Senior Medical Officer (Anaesthesia) (Grade IV/III)

Qualification requirement:

<u>For Grade-IV post</u>: MBBS + PG Degree in **Anaesthesia** + 3 years post qualification relevant experience

<u>For Grade-III post</u>: MBBS + PG Degree/PG Diploma in **Anaesthesia** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to independently anaesthetize for major and minor surgeries and attend emergencies.
- Should be well versed with ICCU procedures including ventilator application.
- Should be able to manage cases attending Emergency Room as and when required.
- Should be able to perform duties as a General Duty Medical Officer.

1.3. Medical Superintendent/Senior Medical Officer (Paediatrics) (Grade-IV/III)

Qualification requirement:

<u>For Grade-IV post</u>: MBBS + PG Degree in **Paediatrics** + 3 years post qualification relevant experience.

<u>For Grade-III post</u>: MBBS + PG Degree/PG Diploma in **Paediatrics** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to manage all Paediatrics cases efficiently.
- Must have good knowledge in neonatology e.g. New born Resuscitation, preterm babies management, managing Septicaemia in newborn etc.
- Must have good knowledge in incubator and nursery care.
- Should be able to manage cases attending emergency room as and when required.
- Should be able to perform duties as a General Duty Medical Officer.

1.4. Medical Superintendent/Senior Medical Officer (Pathology) (Grade-IV/III)

Qualification requirement:

<u>For Grade-IV post</u>: MBBS + PG Degree in **Pathology** + 3 years post qualification relevant experience.

<u>For Grade-III post</u>: MBBS + PG Degree/PG Diploma in **Pathology** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to manage Pathology Laboratory with Bio chemistry, cytology, Histopathology, Hematology and Serology etc independently.
- Experience in Microbiology will be an added advantage,
- Should be able to manage cases attending Emergency Room as and when required.
- Should be able to perform duties as a General Duty Medical Officer.

1.5. Medical Superintendent/Senior Medical Officer (Ophthalmology) (Grade-IV/III)

Qualification requirement:

<u>For Grade-IV post</u>: MBBS + PG Degree in **Ophthalmology** + 3 years post qualification relevant experience

For Grade-III post : MBBS + PG Degree/PG Diploma in **Ophthalmology** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to independently handle OPD & Ward cases and be able to perform independently all types of Minor and Major Ophthalmic surgeries.
- Should be able to manage all the Industrial accidents leading to eye injuries independently.
- Should be able to manage cases attending Emergency Room as and when required.
- Should be able to perform duties as a General Duty Medical Officer.

<u>For Grade-III post</u>: MBBS + PG Degree/PG Diploma in **Orthopaedics** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to manage closed, open fractures and multi trauma patients.
- Should be able to perform Orthopaedic surgery independently.
- Management of fractures and dislocations.
- Knowledge in Arthroscopy / Arthroplasty will be an added advantage.
- Should be able to attend and manage cases independently in the emergency room as and when required.
- Should be able to perform duties as a General Duty Medical Officer

1.7. Medical Superintendent/Senior Medical Officer (ENT) (Grade-IV/III)

Qualification requirement:

For Grade-IV post: MBBS + PG Degree in **ENT** + 3 years post qualification relevant experience.

For Grade-III post : MBBS + PG Degree/PG Diploma in **ENT** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to manage ENT cases independently.
- Should be able to perform routine ENT surgeries independently.
- Should be able to detect cases of noise induced hearing loss and take measures for prevention of the same.
- Knowledge and experience in micro ear surgery and endoscopic sinus surgery will be an added advantage.
- Should be able to perform duties as a General Duty Medical Officer
- Should be able to attend and manage cases independently in the emergency room as and when required.

1.8. Medical Superintendent/Senior Medical Officer (Obstetrics & Gynecology) (Grade-IV/III)

Qualification requirement:

<u>For Grade-IV post</u>: MBBS + PG Degree in **Obstetrics & Gynecology** + 3 years post qualification relevant experience.

<u>For Grade-III post</u>: MBBS + PG Degree/PG Diploma in **Obstetrics & Gynecology** + 1 year post qualification relevant experience.

Experience/Job requirement:

- Should be able to manage and conduct Normal and Assisted deliveries.
- Should be able to deal with Gynecological and Obstetrical Surgery independently.
- Should be able to manage Antenatal and Postnatal cases.
- Should be able to resuscitate new-born after deliveries.
- Should be able to manage cases attending Emergency Room as and when required.
- Should be able to perform duties as a General Duty Medical Officer.

1.9. Dy. Manager (Quality Control) (Grade-III)

Qualification requirement:

Degree in **Mechanical Engineering** (Full Time) with 60% of marks in aggregate of all semesters/years + 3 years Post qualification experience in the next below Grade or in equivalent post also, in the relevant area.

Experience/Job requirement:

- Experience in inspection and quality management system and procedures.
- Should have knowledge of product and in –process inspection techniques.
- Should have knowledge of defect investigation, Corrective and preventive action, SQC techniques and vendor quality assurance.
- Should have sound knowledge of ISO 9000, ISO 14000 and AS-9100 C.
- Should be able to conduct internal quality audits of various departments.
- Should be able to co-ordinate with various Govt. agencies and shops to meet the task in time
- Should have knowledge of computer operation.
- Should have knowledge of various NDT Techniques, level-II ASNT or ISNT in any one process desirable.

- Should have team building capabilities and ability to guide the team for achieving the results in a time bound and effective manner.

- Knowledge of various Industrial engineering functions and MIS reporting system.
- Knowledge in various machining process and process parameters for aero engine materials.
- Knowledge of process time estimation and establishment of standard time for processes/ man-power planning, synthetic data development / resource planning/ optimization of capacity utilisation.
- Exposure to various incentive scheme, suggestion scheme, productive improvement measures and quality management system.
- Exposure to lean management concepts.

Experience/Job requirement:

- Experience in co-ordinating activities of production engineering, planning, loading, controlling & the production activities of a shop involving large number of components & sub assemblies.
- Experience in project planning & monitoring in any complex product/multi product industry.
- Should be able to study the feasibility of a new project and prepare preliminary project report independently.
- Should have sufficient knowledge on budgeting finance, cash-flow, outsourcing.
- Should have good knowledge in computer application, especially in PPC and should be able to carry out assignments in latest project software on computers.
- Should be conversant with PERT/CPM techniques.
- Should have working knowledge in ERP.
- Desirable of having experience in outsourcing activities.

Experience/Job requirement:

- Experience in activities of Commercial / Purchase Dept in connection to procurement of technical and others in connection with the production activities of a shop involving large number of components & sub assemblies.
- Should have sound commercial sense with negotiation skills and knowledge of Govt. policies related to purchase.
- Should be able to manage the tendering process, perform analysis of offers through comparative statement.
- Should have sound knowledge in custom formalities, High Sea sale Agreement, Inco Terms, Excise and Sales Tax formalities etc.

- Should be familiar with Export/ import procedures and be able to handle disputes/claims including insurance claims.

Degree in **Electronics & Communication Engg.** (Full Time) with 60% of marks in aggregate of all semesters/years + 3 years Post qualification experience in the next below Grade or in equivalent post also, in the relevant area.

Experience/Job requirement:

- Should be familiar with maintenance, Trouble shooting and fault finding of NC, CNC machines, vacuum furnaces, balancing machines and electronic discharge machines and electro plating baths.
- Should be familiar with different CNC controls like Siemens, Fanuc etc.
- Should be familiar with maintenance of thyristor controlled manpower electronics, Able to repair and fault finding of Power Electronics cards.
- Should be familiar with different types of thermocouples, RTDs and furnace heater elements.
- Should be able to configure and maintenance of different of different temperature controllers like ON/OFF, proportional and PID.
- Should be able to write technical specifications and able to do technical evaluations.
- Should be able to manage a group staff.

- Should have experience in a reputed institution / industrial laboratory with hands on experience in Mechanical testing / Metallography/NDT/Chemical / failure analysis.
- Should have experience to interpret the testing data of metallographic inspection.
- Level III approval in any one of the NDT techniques desirable.

2. AGE LIMIT/ RELAXATION / CONCESSION

- a) Upper age limit not above 45 years as on **01.11.2012** for General category candidates. Upper age limit is relaxable by 5 years in respect of SC/ST category candidates. Upper age limit is relaxable by 3 years in respect of OBC (non creamy layer) candidates.
- b) In respect of Persons With Disability (PWDs), the upper age limit is relaxable by 5 years for general candidates, which will be over and above the relaxation admissible for candidates belongs to SC/ST/OBC.
- c) Age relaxation will be extended as per rules in respect of Ex-Servicemen/ Commissioned Officers / ECOs / SSCOs, who have rendered at least 5 years of Defence service and have been released on completion of assignment.
- d) For candidates who had ordinarily been domicile in the State of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989, upper age limit is relaxable by 5 years. However age limit with all relaxations shall not exceed 55 years.
- e) Candidates belonging to OBC category are required to produce recently obtained community certificate in proof of their community at the time of their Interview (not older than 6 months as on **01.11.2012** in the format prescribed by the Government of India, stating that they do not come under the creamy layer, from a competent authority.

Besides Basic Pay, Variable DA, SCA @10% on running Basic Pay, Company Accommodation/HRA, Perquisites & Allowances (at the rate of 40% on running Basic Pay for Gr-IV Officers and 42% on running Basic Pay for Gr-III Officers), PF, Gratuity, Performance Related Pay (PRP) are also admissible as per Company rules. 6. GENERAL CONDITIONS

- i) Only Indian Nationals need to apply. Mere submission of application will not entitle any right for claiming Appointment.
- ii) AMIE courses by Institute of Engineers (India), Kolkata, are also eligible. Graduate IIIE course from Indian Institution of Industrial Engineering, Mumbai under production discipline, are also eligible.
- iii) Minimum percentage of marks in the essential qualification as indicated above shall be aggregate of all semesters to be calculated taking average of all semesters/years, irrespective of the weightage given to any particular semester/year by the Institute/University. No rounding off will be done.
