Age Limit: Between 18 to 32 years for General Category candidates, as on closing date of receipt of application.

4 (A) Relaxation for age limit:

- i) Up to the period of trade apprenticeship.
- ii) Up to 5 years for SC & ST Candidates.
- Up to 3 years for OBC Candidates on production of Caste Certificate with "Non-Creamy Layer" Clause issued by the Competent Authority.
- Up to 40 years for Departmental Candidates with 3 years continuous service (additional 5 years for SC/ST and 3 years for OBC Candidates).

05. Educational Qualifications and other qualifications:-

- i) Passed Matriculation or equivalent examination
- ii) National Council for Vocational Training (NCTVT) Certificate in the relevant trade failing which by ITI or equivalent Diploma / Certificate holder.
- iii) For considering the C.P.W Trade / Post, NCTVT certificate in Attendant Operator in Chemical Plant (AOCP), failing which by ITI pass or equivalent Diploma / Certificate holder will be considered.
- iv) For Boiler Attendant (Semi-Skilled), must posses a first class Boiler Attendant certificate.

Note:- It is clarified that if applicants with NCTVT certificates as mentioned above are not available in the relevant trade, then only applications with ITI or equivalent Diploma / Certificate holders in relevant trade will be considered. Interchanging of trade will not be permissible.

06. Mode of Selection:

- The selection process will comprise of Written Test of 100 marks and Trade Test (Practical).
- ii) All eligible candidates will be called for Written Test.
- iii) Written Test will be objective type and OMR based.
- iv) The Trade Test (Practical) will be only qualifying in nature, without any marks.
- On the basis of merit list based on marks obtained in Written Test. Candidates, 1.25 times the number of vacancies will be called for Trade Test (Practical)
- The final select list will be based on marks in the Written Test only, the Trade Test being qualifying in nature. The final select list will be based on the marks of written test only. The final select list will be prepared in order of merit of those candidates who will qualify the Trade Test.
- vii) The syllabus for the written test for a trade will be of the NCTVT Examination for the trade and as per the functional requirement of that trade.

viii) The syllabus for the Trade Test will be as per the trade test specification of the semi-skilled grade of the relevant trade

In selection process, other things being equal i.e. marks being equal, trained Ex-Trade Apprentices of HEF and sister Ordnance Factories shall be given preference in the order in which they are stated.

In between the trained Ex- Trade Apprentices of the recruiting factory, preference shall be given to those who are senior i.e if two or more Ex. Trade apprentices secure same marks then preference shall be given on the basis of seniority. Seniority of Ex.- Trade Apprentices of the recruiting Ordnance Factory shall be decided on the basis of OFB's letter No. 13/08/03 –A/HRD dated 15/17-12-2003. and the relevant portion is reproduced below:

The NCTVT examination batch numbers (month / year) will be the criteria for maintaining the seniority of Ex. TAs. The merit list of the particular NCTVT examination will be the criteria of seniority for Ex-TA for that batch. Factory will maintain batch wise, trdae wise Ex-TA seniority strictly as per the NCTVT examination irrespective of whether the candidate is EX-ITI or a fresh apprentice. In other words, the Ex-TA who has passed NCTVT examination in an earlier batch (NCTVT) is enblock senior to the Ex-TA passed in the subsequent batch irrespective of the year of joining Trade Apprnetice Scheme. Similarly, in between the trained apprentices of the sister Ordnance factories, preference shall be given to those who are senior as mentioned above.

07. Fees: Rs.50.00(Rupees Fifty Only) through crossed Indian Postal order / Demand Draft of a Nationalized Bank drawn in favor of The General Manager, High Explosives Factory Khadaki Pune 411 003. Payable at GPO/PUNE, incase of Demand Draft Payable at SBI Khadki Pune 411 003. No fee will be charged from SC/ST Candidates **The application fee is non-refundable**.

08. Important instructions to the Candidates / Applicants.

- i) The selection will be based on Merit only
- Name of the Post, Category and Language of written examination (Hindi or English) as per choice must be clearly superscripted / written on the top of the envelop in CAPITAL LETTERS.
- Mere fulfilling the minimum prescribed qualification will not vest any right upon the candidate for being called for the test. The factory will not entertain any correspondence in this respect and interim inquiry will not be attended to.
- Persons working in Central / State Govt. / PSU must apply through proper channel along with a certificate from their Establishment that neither any disciplinary case is pending nor contemplated against them. They must also enclose a certificate from the Establishment concerned that in case of selection, their Establishment will release them immediately.
- New entrants to Government Service will be governed by New Pension Scheme termed as "Defined Contribution Pension Scheme" and existing provisions of CCS (Pension Rules), 1972 will not be applicable to new recruits to central Govt. service who have joined Govt. service on or after \$\pi\$ 01.01.2004.

- Travelling Allowance: Candidates appearing in Written Test will have to appear the selection Test at their own expenses. However, SC / ST candidates will be paid travelling allowance of second class Railway / Bus fare as per rules for onward and return journey performed by shortest route on production of journey details as well as Railway receipts / Bus Ticket and attested photocopy of SC / ST certificate, provided that to and fro distance traveled is more than 30 KMs.
- vii) Candidates belonging to SC/ST/OBC Categories shall submit caste / tribe certificate in prescribed format issued by Competent Authority as applicable for reservation as per rules. OBC Certificate must specifically include clause regarding "exclusion of Creamy Layer" and should be updated / valid at the relevant point of time i.e the last date of receipt of application.
- viii) Last date of receipt of application: Application complete in all respect along with required details shall reach the General Manager, High Explosives Factory, Khadki, Pune 411 003 within 21 days of the publication of advertisement in the Employment News.
