 - Technical qualification
 - d. Other qualifications / experience, if any
 - e. Community certificates of those belonging to SC/ST/OBC and
 - Employment Exchange Registered card
- 13. <u>General Instruction</u>: The application forms should be accompanied by two recent conduct certificates from TWO Gazetted Officers [originals to be sent]. Applications to which only one conduct certificate is attached will be rejected.

Candidates called for interview will have to bear their own expenses.

Candidates selected for training will not be allowed to withdraw from training except for reasons, which are beyond their control. Before commencement of the training, the candidates will have to execute a triplicate contract of Apprenticeship. Those who willfully absent themselves are liable to refund the whole cost of their training as well as the amount paid as stipend as determined by the Central Apprenticeship Adviser.

The engagement and training are strictly in compliance with the provisions of the Apprentices Act 1961 and there is no guarantee for employment of the Apprentices on completion of their training.

Every Apprentice who has completed the period of training will, on passing a test to be conducted by the National Council for Training in Vocational Trade to determine his proficiency in the designated trade in which he has served as an Apprentice would be given a certificate of proficiency in the trade by the National Council.

Application with incomplete particulars or without attested copies of certificates required to be attached or otherwise not in accordance with other instructions will be rejected.
