Stipend: - Rs. 10,000/- p.m.

Mode of Selection: In case large number of candidates turn up, the candidates will be shortlisted for interview through a written test or Group discussion by a duly constituted Screening Committee. Only the shortlisted candidates shall be interviewed by the Selection Committee.
