### **Syllabus and Pattern of Examination:**

### 1. Minimum Qualification

Applicants must fulfill all the requirements of the post and other conditions as stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess the essential qualifications laid down for the relevant post.

Candidates should mention all their qualifications and experiences in the relevant field and should attach attested copies of the certificate in support thereof.

### 2. Service Conditions

• The candidates finally selected for appointment will be under ICAR service and are likely to be posted to any Units under Indian Institute of Vegetable Research, Varanasi and will also be liable to be appointed/transferred to any where in India.

- The persons selected for appointment will be on probation for a period of two years, which may further be extended at the discretion of appointing authority.
- Candidate must be in a sound mental and physical health and free from any physical illness which is likely to interfere in the efficient discharge of his/her duties. A candidate who after such medical examination, as may be prescribed by the competent authority, is found not to satisfy these requirements will not be appointed. Only such candidates as are likely to be considered for appointment will have to be medically examined. The candidate has to be declared medically fit for the service by the competent medical authority.

## 3. How to apply

- Candidates must apply in the application format published alongwith this advertisement and fill up all the columns in their own hand in block letters. Candidate may also apply on plain paper but the format should exactly be the same as given.

### 4. Action against candidates found guilty of misconduct

  - (k) Bringing mobile phone/communication device in the examination hall/interview room.

### 5. Instruction for Departmental Candidates/Govt. employees






