- 3) The applications in prescribed format, complete in all respects should reach the office of Registrar, Sher-e-Kashmir University of Agricultural Sciences & Technology of Kashmir, Shalimar campus, Srinagar. by the stipulated date duly accompanied with self addressed envelope (10" x 4"), affixed with postal stamp of ₹ 5/- and a Bank Draft for ₹ 500/- (Rupees five hundred only) non-refundable pledged to *Comptroller, Sher-e-Kashmir University of Agricultural Sciences & Technology of Kashmir, Shalimar-191 121, Srinagar payable at J&K Bank Ltd. - 5) The candidates selected/appointed on the above posts, borne on the KVKs, shall be transferable within KVKs of the University only. However, the University reserves the right to transfer these appointees to any constituent unit.
- 6) That the University shall, resort to short listing of the eligible candidates to be called for interview before the Selection Committee. The short listing can be done on the basis of merit obtained in the academic qualifications and /or any other standard method including a written test to be adopted by the University.
- 7) Only short listed candidates shall be called for interview.
- 8) The University reserves the right to defer filling up of any or all posts advertised here in above without assigning any reason thereof.
- 9) The appointment on the above posts shall be co-terminus with the scheme.
- 10) In-service candidates are required to route their applications through proper channel.


- 11) The number of posts indicated above is subject to increase or decrease at the discretion of the University at the time of appointment.
