

ADMISSION PROCEDURE FOR MBBS – 2013

All candidates who have been allotted a seat will be allowed to take print out of PROVISIONAL ALLOTMENT LETTER from **Online Counselling Portal – MBBS 2013**, on 29.08.2013 at 2.00 p.m. onwards. Admission to the allotted seat is subject to verification of all relevant ORIGINAL documents / certificates. The Allotment will be liable to be CANCELLED if the candidate fails to produce the requisite documents / certificates in ORIGINAL before the verifying authority at the time of admission **OR** if found medically unfit at the time of Medical check up conducted by concerned colleges.

Candidates must bring the following documents / certificates in ORIGINAL for verification and submission at the time of admission:

1. Admit Card, Mark Sheet, Original / Provisional Passing Certificate of Class 10th / Matriculation.
2. Admit Card, Mark Sheet, Original / Provisional Passing Certificate of Class 12th / Intermediate.
3. NEET-UG Admit Card.
4. Print-out of **PROVISIONAL ALLOTMENT LETTER** taken from the Counselling web portal after declaration of Counselling result.
5. Filled-in Anti Ragging Affidavit in the format given hereunder will have to be submitted in original at the time of taking admission at Institute.
6. C.L.C. / S.L.C. is required to submit at the time of Admission.
7. All candidates who have been allotted a seat in online Counselling, will have to submit a non-refundable Counselling fee of Rs.200/- (Rupees two hundred) only through CHALLAN in J.C.E.C.E. Board A/c and handover Board's copy to the allotted institutes at the time of Admission.
8. Admission Fees, as application to Government Institutions, is required to be paid at the time of admission, which is approximately as follows:-
 - a. R.I.M.S., Ranchi - Rs. 15,000/- (Cash)
 - b. M.G.M.C.H., Jamshedpur - Rs. 20,000/- (Cash)
 - c. P.M.C.H., Dhanbad - Rs. 10,000/- (Cash)
9. Scheduled Caste / Scheduled Tribe/BC-I/ BC-II candidates are required to produce the Caste Certificate of Jharkhand in original issued by [SDO (Civil) /DC] at the time of admission without which their claim for reserved seats will not be entertained and thereby cancellation of allotment.
10. All the Candidates are required to produce the Residential Certificate of Jharkhand issued by SDO (Civil)/DC at the time of admission.

Undertaking from students (Annexure I) & their parents/guardian (Annexure II) should be submitted positively at the time of admission as per the directive contained in the UGC REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTES, 2009 vide F.1-16/2007 (CPP-II), dated 17th June, 2009.
