## **NOTIFICATION**

The Special Convocation for the year **2012** will be conducted in the month of March 2012. In this Convocation, the Degree/Diploma of all the faculties will be conferred on only those candidates who have passed their respective Degree/Diploma examinations held during the period from 11.11.2011 to 31.12.2011. The exact date and time of the convocation will be announced later.

However, those who have passed prior to **2012** are also eligible to apply for the ensuing Convocation, but the Convocation fees will be based on the year in which he/she has passed the degree/diploma. Hence, refer to the fee chart to obtain the information on applicable fees.

Applications duly completed in all respects shall reach the Registrar(Evaluation), Karnatak University, Dharwad on or before **25.02.2012** without penal fees, and with penal fees of **Rs.75/-up to 29.02.2012**. Late and incomplete applications will not be entertained.

The convocation form is available in the Examination Section Enquiry Counter or it can be downloaded from the university website <a href="www.kud.ac.in">www.kud.ac.in</a>. Fill all the fields with appropriate information needed, send the application along with the applicable fees in the form of DD drawn in favour of Finance Officer, Karnatak University Dharwad, payable at Dharwad or challan confirming the payment of fees in any of the banks shown below or bank challan indicating direct transfer of fees to one of the bank accounts indicated below. The DD/Challan or direct transfer shall be for total fees including the application fee of **Rs. 80-00.**

The candidates shall write their correct name as in the statement of marks at the qualifying examination both in English and Kannada. The attested copy of the statement of marks for final year shall be enclosed along with the application.

All the Medical candidates have to enclose an attested copy of the Compulsory **HOUSEMANSHIP CERTIFICATE** issued by this University.

The candidates, qualified for the following Degree/Diploma, between the months of 11<sup>th</sup> November to 31<sup>st</sup> December 2011 only, are eligible to apply for conferring degree in person:

- a. Ph.D.
- b. P.G. Regular candidates
- c. P.G. Diploma candidates

Those candidates who have passed B.A./B.Com Part-I, II as external students and have subsequently passed B.A./B.Com. Part-III as Regular students, will be awarded only external degrees. Hence, the external students should clearly mention this fact on their applications and enclose attested copies of statement of marks of the Part-I, II, III examinations.

The candidates who apply IN PERSON, and does not attend the convocation will be required to pay an additional absentia charges of **Rs.180/-** and then only Degree Certificates of such candidates will be sent by post.

The Degree Certificates of the candidates admitted as "IN ABSENTIA" will be sent by SPEED POST TO THEIR ADDRESS AFTER THE CONVOCATION IS OVER. Further, if there are any corrections in degree certificates, candidates shall submit the same for corrections within six months along with applicable fees from the date of receipt by post/by hand.
