IMPORTANT INSTRUCTIONS FOR ADVERTISEMENT NO. 2/2012

Candidates must go through the following instructions before filling up the application form:

- 1. Reservation of posts for SC/BC/PH/Ex-Servicemen will be for Haryana Residents only and as per other conditions of Reservation Policy of State Government/University.
- 2. The prescribed essential qualifications do not entitle a candidate to be called for interview. The decision of the University in all matters relating to acceptance or rejection of an application, eligibility/ suitability of the candidates, or the criteria for selection, etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
- 3. The appointment under Self-Financing Scheme will be made in the running grade for five years. After 5 years their work and conduct will be reviewed for continuation of their services, which will be co-terminus with the specific course or date of superannuation, whichever is earlier. The persons appointed will be entitled for basic pay in the pay band + Grade pay, ADA, HRA, fixed medical allowance, CPF, annual increment. They will also be entitled for Earned leave, Maternity leave, Anti Rabic leave, Quarantine Leave, Extra Ordinary Leave (Without pay), Academic leave, Study leave (without pay), Casual leave, Child Care Leave (without pay), Vacations and forwarding of applications for State/Centre Government jobs.
