COMPANY PROFILE

Neelachal Ispat Nigam Limited (NINL), a company promoted by MMTC Ltd, Industrial Promotion and Investment Corporation of Odisha limited (IPICOL) and other government agencies has set up an 1.1 million ton Integrated Iron and steel plant at Kalinganagar, Duburi, Dist-Jajpur, Odisha.

NINL is a full-fledged integrated steel plant engaged in production of steel billets of different qualities with continuous improvement in productivity and consumer satisfaction. The BF coke produced by NINL is of high quality and supplied to almost all units of Steel Authority of India Ltd and Vishakhapatnam Steel Plant. The "KAMDHENU" fertilizer (Ammonium Sulphate) produced, is also in high demand.

NINL is having 62.5 MW captive power plant to meet the power requirements. Apart from meeting own requirement NINL is exporting surplus power to GRIDCO, Orissa.
