**Minimum Qualification:** The applicant should have M.F.Sc (Aquaculture) degree from a recognized University / Institute having an OGPA of 3.20/4.00 or 7.00 / 10.00 or 70% marks under traditional system. For reserve category (SC/ST) minimum eligibility will be 65% or 6.5/10 OGPA of qualifying examination as per rules.

**Vacancy also exists for holders of M.Sc (Zoology) with specialization in Fisheries related subjects. This candidate will however be required to under take one year deficiency course & shall pay 25000/- per semester in addition to University fees.**
