PH.D. DEGREE

ELIGIBILITY: To be eligible for admission to Ph.D. Degree, the applicant should have

- obtained a Master's Degree in law of any recognised university securing not less than 55% marks or its equivalent
or
- obtained a degree in law and Masters Degree with M.Phil in social sciences or humanities or sciences of any recognised university with not less than 55% marks or its equivalent

Provided that candidates with qualifications in social sciences, humanities and sciences may be admitted to the programme if the research they wish to pursue interfaces with the discipline of law with a special focus on Public Policy or Law.

- or
- iii) Degree in law and Ph.D. in any discipline.
- or
- iv) Judge of any State High Court in India with three years experience or Judge of Supreme Court of India.
- or
- v) obtained two-years Master's in Taxation and Business Laws offered by NALSAR with not less than 55% marks.

Note : For the candidates under this category, the topic shall be in taxation and related subjects and the Degree to be awarded will be Ph.D. in Taxation (only for IRS Officers).

- vi) Passed the Company Secretary examination conducted by the Institute of Company Secretaries of India and awarded the Associate Membership of the Institute (ACS) shall be eligible for admission to the programme if the research they wish to pursue interfaces with the discipline of law with a special focus on Public Policy or Law.
- vii) one year LL.M. with minimum of 55% marks from Foreign Universities provided concerned Foreign University is recognised by Association of Indian Universities (AIU), New Delhi.

- a. The admission shall be through a written test to be conducted on **Sunday, May 6, 2012 from 2.00 p.m. to 4.00 p.m. at NALSAR University Campus, Justice City, Shameerpet, Hyderabad.**
- b. Candidates who have **qualified for UGC NET / JRF, SLET, and M.Phil. are exempted from taking the admission test.**
- c. All **qualified candidates shall submit a research proposal** on the proposed topic of their research on or before a date to be notified by the University.

All Essay Questions: There will be two questions from each specialization offered and the candidates should answer any two questions. All questions carry equal marks.

1. Identification of Problem
2. Research Questions
3. Hypothesis
4. Methodology
5. Data Collection
6. Chapterisation
7. Literature Survey

- After scrutiny, candidates will be called for making a presentation on the proposed topic of their research before the Research Committee. The date will be intimated to the candidates by email / surface mail in advance.
- The selection of the candidates will be based on the performance at the Test and also the presentation of the proposal before the Committee.

All correspondence relating to admission should be made to the Registrar at the City Office address only. The Application Form can be downloaded from the University website and the filled in form should be sent along with a Demand Draft for Rs.2,000/- (Rs. 1,000/- in case of S.C. and S.T. candidates along with Caste Certificate) in favour of "**Registrar, NALSAR**" payable at Hyderabad. The duly filled in Form must reach the **Registrar** on or before **Saturday, March 31, 2012**. Applications received after the last date shall not be accepted under any circumstances. The University will not be responsible for any delay.
