

ADMISSION ANNOUNCEMENT

(Academic Year 2012-13)

Eligibility:

- A candidate should have passed Higher Secondary/Intermediate Examinations (10+2) or its equivalent examinations with not less than 50% marks in aggregate.
- Age of the candidate should not be more than 20 years on 1st July, 2012.

Admission Procedure:

- The prospective candidates are compulsorily required to take the **Common Law Admission Test, CLAT- 2012** which is being conducted by the National Law University, Jodhpur (for more details please refer www.clat.ac.in).
- **The prospective candidates are also required to fill in the application form of the Institute of Law, Nirma University in addition to the CLAT form.**
- Only those candidates who have appeared in CLAT 2012 and have also applied in Institute of Law, Nirma University will be considered for admission, based on *inter se* merit of CLAT 2012.

B.A., LL.B. (Hons.) - 120

B.Com., LL.B.(Hons.) – 60

B.B.A., LL.B. (Hons.) * - 60

15% of the intake is likely to fill in under NRI category as per Government of Gujarat Rules. Over and above 15% supernumerary seats will be for Persons of Indian Origin (PIO/Foreign National (FN) and Children of Indian Working in Gulf Countries and South East Asia (CIWGC) and South East Asia (SEA) as per UGC Rules.

Fee Structure:

- Indian Residents: Tuition FEE – Rs.1,00,000/- per annum (inclusive of all, except refundable Deposits, University fees and Student Activity Fees).
- Foreign Nationals/PIO/NRIs/Gulf/SEA Quota- US \$ 6500 per annum or equivalent in Indian Rupees (inclusive of all, except refundable Deposits, University fees and student activity fees).
