M.A. in Public Policy Admissions Announcement 2012-13



The O.P. Jindal Global University (JGU) is a non-profit university established by the Haryana Private Universities (Second Amendment) Act, 2009 and recognised by the University Grants Commission (UGC) of India. The vision of JGU is to promote teaching and research with a global perspective. JGU is one of the few universities in Asia that maintains a 1:15 faculty-student ratio and appoints faculty members from different parts of the world with outstanding academic qualifications and experience.

JGU has established four Schools: Jindal Global Law School (JGLS), Jindal Global Business School (JGBS), Jindal School of International Affairs (JSIA), and Jindal School of Government and Public Policy (JSGP). The first three Schools are fully functional and have over 50 full-time faculty members and nearly 600 students. The Jindal School of Government and Public Policy is the youngest school at JGU, which will offer a Masters in Public Policy degree programme from August 2012. The University has formed academic networks and started collaborative initiatives with reputed universities and institutions like Harvard, Yale, Columbia, Cornell, Michigan, New York University and Indiana in the USA, York, Queen's and Carleton in Canada and Cambridge in the U.K.

The Jindal School of Government and Public Policy has developed academic and research collaborations with the School of Public and Environmental Affairs (SPEA) of Indiana University in Bloomington, USA and the National Institute of Administrative Research (NIAR), LBS National Academy of Administration, Mussoorie.

Vision Statement

The Jindal School of Government and Public Policy (JSGP) has been established with a vision to understand and engage with the processes of the changing global political economy and locate India within this shifting terrain. JSGP expects to identify and analyse the major policy issues that have emerged in this challenging economic, political and social environment, and participate in the debate by promoting cutting-edge research. Through national and international collaborations, it wants to develop a comparative perspective on policy issues and recommend solutions to the emerging developmental and governance problems.

JGU is committed to academic freedom, and free, liberal and critical thinking. JSGP carries forward this commitment and aims to be an intellectually vibrant place where policy issues can be deliberated and debated in a non-dogmatic, non-partisan, ideologically plural and ecumenical way and in a collegial environment.

It aspires to be a centre of excellence, which will generate knowledge and ideas about development and thereby play a crucial role in the policymaking processes in the country.

JSGP will be a research-driven School. It is committed to establish research centres on topical and contentious subjects. JSGP will develop a research-based pedagogy and the faculty will develop courses based on their current research. The students will receive a grounded education whereby they will be exposed to the field and the actual institutional processes. The scholars and students would interact and exchange ideas with the government and nongovernment actors. JSGP intends to promote interdisciplinary studies and joint teaching and research programmes in partnership with the other Schools of the University. Through such endeavours, it will develop a world-class Masters in Public Policy programme and advanced level executive programmes.


M.A. in Public Policy

The recent upheaval in the global economy and polity has challenged our received understanding about the way the world functions. The certitude of all political ideologies has been thoroughly undermined, which in turn has substantially changed the policy discourses. The debate on debt-fuelled growth led by the state and the private sector and the structural and social consequences of that is wide open. The contemporary economic structure has been found to increase inequality without generating substantial employment or an increase in real wages. It is vulnerable to periodic crises. The need for an effective regulation of the economy and the markets has been echoed around the globe. The problem of poverty and a low level of human development are worryingly still present before us. In absence of any substantial policy intervention, governments have the propensity to resort to populism.

Beyond such short-sighted populist policies, there has been a renewed concern for redistributive justice and a search for innovative and constitutionally guaranteed social welfare policies. This also calls for a better institutional design and capacity to govern and deliver. Attempts are being made to reconcile equity and efficiency within this new governance structure. The challenge before the policymakers and public leaders in India is to find solutions to the problems within the framework of the Constitution and to defend the democratic values, and to resist authoritarian impulses in an attempt to 'catch up' with certain less democratic countries. The MA in Public Policy programme has been designed with an intention to equip the future policymakers and public leaders to face this increasingly complex policy environment.

Programme Objectives

MA in Public Policy (MPP) is an interdisciplinary degree programme that bridges the gap between theory and practice. The programme teaches the students to delve into the contemporary issues in a coherent and holistic manner, to see the interconnections between various aspects of an issue and to be analytically and conceptually rigorous.



The MPP programme will impart a strong training in theory, covering the key literature and debates on a subject or an issue. Students will develop quantitative and qualitative analytical skills, receive an exposure to the real world policymaking process, and enhance their managerial skills. The programme will prepare students to assume leadership position in the field of public policy and institutional management.

Programme Tracks and Structure

The MA in Public Policy programme is offered in two tracks: Regular and Intensive Weekend.

Regular Track: It is a residential, full-time, 5-day a week, degree programme. No work experience is required. The students are required to successfully complete 12 courses, each of 3 credit hours (total 36 credits), write one Policy Analysis Report (PAR) and a dissertation of 12000 words.

Intensive Weekend Track: It is a weekend only, non-residential degree programme. This track has been designed for working professionals. Students are required to successfully complete 12 courses, each of 3 credit hours (total 36 credits), write 2 PARs and a dissertation of 15000 words. The course-work is completed in the first year and in the second year students undertake applied research projects. The Intensive Track students will be exempted from internship as it is assumed that they already have the relevant work experience.

Teaching

Teaching is provided in lecture, seminar and group-discussion formats. Teachers will provide course bibliographies before the commencement of the semester and students are required to prepare before attending the class. Almost all the materials listed on a bibliography will be available in the course-pack and the library will assist students to find further materials. The library will also provide access to a wide-range of database which students will require.

Students will intern at organisations where they will be exposed to the real world issues and problems and the policymaking process. During the internship, students will collect materials for writing the Policy Analysis Report (PAR), which will be a professional consultancy report prepared for the organisation.

Apart from regular lectures, JSGP will organise workshops and seminars on special topics. The School will invite practitioners like activists, senior bureaucrats, politicians, NGO-workers and policymakers from UN and other bilateral and multilateral international organisations to deliver lectures and interact with students.

JSGP will also organise weekly seminars where scholarly papers will be presented and discussed. This will give opportunity to students to engage with the wider intellectual world and acquaint themselves with the topical debates and current research interests.

Assessment

Students are required to write weekly or fortnightly essays which will be commented upon by the respective teachers

Students will be assessed based on their performance in the final examination, quality of their assignments, PAR and the dissertation. Each student will be assigned a supervisor for designing research methodology, conducting fieldwork and writing the dissertation.

Careers in Public Policy

Students will be equipped to join the development and policy sector, and work in international organisations, bilateral and multilateral organisations, civil service, think-tanks; work as an independent consultant for government and non-governmental organisations, or start their own organisation. They can work as academicians, researchers, or journalists. JSGP will provide additional academic and advisory support to students planning to go for doctoral studies.

Admission Eligibility

Applicants to the MPP programme at JSGP must have a Bachelor's degree (B.A., B.Sc., B.Com., B.E., B.Tech., B.B.A., LL.B., M.B.B.S., etc.) from any university in India or abroad that is duly recognised under law and by the regulatory authorities. Students who will be graduating by Summer of 2012 can also apply. There is no age limit. No work experience is required for candidates applying for the Regular track. For the Intensive Weekend track, candidates are expected to be working professionals or have demonstrable work experience.

Entrance Examination

JSGP will follow a rolling entrance examination system. Candidates will be assigned a date to sit for an online written entrance examination. Candidates can consult books. JSGP will reject essays and applications of candidates suspected of plagiarism. After the written examination, the shortlisted candidates will be interviewed via telephone. A list of selected candidates will be drawn after the interview and based on the position on the selection list, scholarships, fellowships, assistantships and applicable fee waivers, ranging from full to partial, will be provided to meritorious candidates.

Fees

Regular Track: Programme fee: Rs. 3 lakhs per annum; Fee for Food, Accommodation and Laundry: Rs. 1.25 lakhs per annum. Total: Rs. 4.25 lakhs per annum.

Intensive Weekend Track: Rs. 3 lakhs in the first year and Rs. 1 lakh in the second year.

Scholarships

O.P. Jindal Outstanding Merit Scholarship

The top scorers in the admission test will be awarded the O.P. Jindal Outstanding Merit Scholarship of Rs. 1 lakh each.

Savitri Jindal Merit cum Means Fellowship

To facilitate the accessibility of meritorious students, who may not otherwise be able to afford to study due to their economic standing and inadequate financial support, JSGP is offering this fellowship.

Naveen Jindal Young Global Leaders Scholarship

An award of Rs. 5 lakhs will be given to the selected students to nurture, encourage and support young leaders.

Shallu Jindal Outstanding Women Scholarship

An award of Rs. 2 lakhs will be given to the selected students to nurture, encourage and support outstanding women to enter the field of public policy.
