The students are advised to enclose Xerox copies of their qualifying examination certificates attested by the College Principal concerned with the Examination Application Form and Migration Certificate, if any , with Migration Fee of **Rs.125/-**(if the candidate belongs to other than O.U./ SBTET).
2. The Principals are requested to furnish the list of candidates admitted in their Colleges during the academic year 2013-2014 duly approved by the Convener, EAMCET and also the Director, Admissions, O.U.
