- 1. Separate application forms should be submitted for each year of examination.
- 2. The exact date of commencement of the examinations and detailed time-table will be notified later.
- 3. The Examination application forms can be had from the respective Colleges/Director, University Press and Publications Osmania University, Hyderabad on payment from 19. 08.2013 onwards.
- 4. Candidates who have applied for revaluation/recounting also have to pay the examination fee as per the above schedule without waiting for the results of revaluation/ recounting as the case may be.
- 5. The examination fee once paid by the candidate will **not refunded** in any case.
- 6. - 9. Instruct the students to enclose the Xerox copies of Memorandum of marks of earlier Examination.
- 1. Application forms with all the above requirements should reach the Examination Branch, O.U on or before 25th September 2013. A penal fee ₹ 500/- will be collected per day from the college on applications received after 25th September 2013.
