The Colleges those maintaining their account with the branches of State Bank of Hyderabad can remit the fees through the same branch for credit of Registrar, Osmania University Examination Fee Fund A/c No. 52198262033 maintained with **Osmania University Branch of State Bank of Hyderabad**.

In case the College is maintaining its account with any Bank other than State Bank of Hyderabad they are required to deposit money in any Branch of State Bank of Hyderabad for credit into Registrar, Osmania University Examination Fee Fund A/c No. 52198262033.

Further after remitting the Examination fee into Registrar Examination Fee Fund Account through Core Banking system the Colleges can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examination Forms.

The Principal is requested to forward all the Examination forms duly certified on or before **13.03.2013** without fail. Forms received after **13.03.2013** will be levied penal fees of **Rs.1000/-** per day.

The Principal is requested to verify the eligibility of the candidates for admission to the above course and forward the examination application form duly certified.
