 - a) Last date for payment of examination fee without late fee and submission of Examination forms at the respective Colleges.



b) Last date for payment of examination fee with a late fee of **Rs.300/-** and submission of examination application forms at the respective Colleges.



- 5. IN ADDITION TO THE ABOVE EXAMINATION FEE, EACH CANDIDATE APPEARING <u>I-SEMESTER</u> EXAMINATION FOR THE FIRST TIME IS REQUIRED TO PAY <u>RS.400</u>/- EXAMINATION PROCESSING FEE (ONCE IN A COURSE TIME).
- 6. Fresh candidates appearing for <u>I-Semester</u> shall enclose Xerox copies of their qualifying Degree Certificates (i.e. provisional & Convocation certificates) duly attested by the Principal of College concerned. The other University candidates should enclose their <u>Original Migration Certificate together with a fee of Rs.150/-</u>in addition to the examination fee.
- 7. i) The Principals are requested to forward all the examination application forms of the eligible candidates duly attested on or before <u>04.11.2013</u> without fail. Forms received after the due date will be levied a penal fee of <u>Rs.1000/-</u> per day.
 - ii) Further, the Principals are requested to submit <u>COMPULSORY</u> the following documents, other wise their forms will not be accepted.
 - 1) The detailed fee statement signed by the college Principal.
 - 2) The list of admitted I-Semester candidates for the year 2013-2014 signed by the Director, P.G. Admission, O.U.
 - 3) No Dues Certificate and Affiliation extension order for the year 2013-2014 with sanctioned strength issued by the Academic Branch, O.U.
 - 4) The clearance certificate from the Director, Directorate of Academic Audit, O.U.
 - 5) The copy of online EAF form signed by the candidate after verifying the Name, Father name and Paper Titles.
 - 6) Clearance certificate from Nodal Officer, Statistical Cell, O.U.
 - iii) ALL THE REGULAR CANDIDATES OF I & III-SEMESTER (13 & 12 BATCHES) SHOULD SUBMIT THEIR EXAMINATION FORMS THROUGH ONLINE ONLY.
- iv) The College will be held responsible for any mistake committed while filling the candidate name, father name and paper title (Theory & Practical) through ONLINE. <u>IN CASE OF ANY MISTAKE RS.1000/-</u> will be levied as <u>FINE</u> for rectification of each error.
