2. DETAILS OF EXAMINATION FEE :-

- i) Fee For All Papers Rs.3000 + Rs.60 = 3060/-
ii) Examination Processing Fee Rs.400/-
(Once in a course time to be paid while appearing First Semester Examination First time)

iii) EXAMINATION FEE ONCE PAID CANNOT BE REFUNDED OR ADJUSTED.

3. Fresh candidates appearing for I-Semester shall enclose Xerox copies of their Qualifying Degree certificates (i.e. Provisional & Convocation certificates) and III-Semester candidates should enclose Xerox copies of their earlier Examinations memo duly attested by the Principal of College concerned. The other University candidates should enclose their **Original Migration Certificate together with a fee of Rs.150/-** in addition to the examination fee.

4. i) The Principal is requested to forward all the Examination application forms of the eligible candidates duly attested on or before **04.12.2013** without fail. Forms received after the due date will be levied a penal fee of **Rs.1000/-** per day.

ii) **Further, the Principals are requested to enclose the list of admitted candidates for the year 2013-2014 signed by the Director, P.G. Admissions along with I-Semester candidates.**

iii) **ALL THE REGULAR CANDIDATES OF I & III SEMESTER SHOULD SUBMIT THEIR EXAMINATION FORMS THROUGH ONLINE ONLY.**

- iv) The Principal of the college is requested to enclose “**NO DUES CERTIFICATE**” and a copy of the Affiliation extension order for the Year **2013-2014** with sanctioned strength issued by the Academic Branch, O.U. and “**CLEARANCE**” FROM THE DIRECTOR, DIRECTORATE OF ACADEMIC AUDIT AND A CERTIFICATE OF COMPLIANCE FROM THE NODAL OFFICER, STATISTICAL CELL, O.U. Otherwise their examination forms will not be accepted.

- v) Submitted the detailed **fee statement** signed by the College Principal.
