(iii)	a person who has been a Graduate or Technician or Technician (Vocational) apprentice under the Act and in whose case the contract of apprenticeship was terminated for any reason whatsoever shall not be eligible for being engaged as an apprentice again under the Act without the prior approval of the Apprenticeship Adviser.

	(i)	The candidate has to give a Declaration that he has not undergone Apprenticeship Training anywhere, under the Acts.	
	(ii)	If the gap between the declaration of the result and the commencement of training is less than one year , a self-affidavit is sufficient and if the gap is between one to three years, a Court Affidavit should be submitted in the same format as Declaration.	
	(iii)	A candidate is not eligible to undergo apprenticeship training if the gap is more than three years.

	On completion of Apprenticeship Training, no employment in the Factory is guaranteed.

	Hostel Accommodation will be provided on payment as per Rules subject to availability. Apprentices are entitled for Medical Treatment at OF Bhandara as per Ordnance Factories Medical Rule.
