The Colleges maintaining their account with the branches of State Bank of Hyderabad (SBH) OR any other bank are required to deposit the consolidated amount in any branch of SBH for Credit into **“Registrar, Osmania University Examination Fee Fund A/c No.52198262033”** and can obtain a receipt from the bank and submit the same to the Examination Branch along with Examination forms on or before **28-03-2013.**

**Application Forms submitted after 28-03-2013 will have to pay a Penal fee of Rs. 1000/- per day.**

**NOTE :**

1. As a part of the Core Banking System all the students are here by instructed to deposit the examination fee into their respective College Account only for onward Transmission to the University by the College.
2. The students are advised to enclose xerox copies of their previous examination Memo of Marks attested by the College Principal concerned with the Examination Application Forms.
3. All the Principals are requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
