### Fee Structure:

- 1. The prescribed Examination fee for **M.Ed I Semester is Rs.880**/- + Memo of Marks Charges **Rs.60**/- + Processing Fees of **Rs.300**/- the total fee is **Rs.1240**/-.
- 2. The candidates are advised to enclose the Xerox copies of B.Ed Degree Certificate and the candidates other than OU have to submit the Migration Certificate (Original) with a fee of Rs.125/-.

The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submit to the Examination Branch duly signed by the student and the principal concerned along with photocopy of qualifying examination. Xerox copies of Examination Application Forms & Photographs will not be considered.

### Note:-

- 1. The Principals are requested to verify and forward all the application froms received by them immediately on or before **20-11-2013**.
- 2. The Principals are requested to submit the examination application forms alongwith name list, fee particulars and subject wise data in duplicate.
- 3. The Principals are requested to enclose the list of admitted candidates for the year **2013-2014** signed by the **Director, Directorate of Admissions.**
- 4. The Principals are requested to submit the fee only for received application forms and not to pay the fee for un-received application forms. Any excess fee paid for un-received application forms is not refundable, individual demand drafts submitted by the students will not be accepted.
- 5. The Principals of the Colleges are requested to enclose "NO DUES CERTIFICATE" and a copy of the Affiliation extension order for the year 2013-2014 with sanctioned strength issued by the Academic Branch, OU and "CLEARANCE" FROM THE DIRECTOR, DIRECTORATE OF ACADEMIC AUDIT AND A CERTIFICATE OF COMPLIANCE FROM THE NODAL OFFICER, STATISTICAL CELL, OU, otherwise their examination forms will not be accepted.

- 6. As a part of the Core Banking System, all the students are hereby instructed to deposit Examination fee into their respective College Principal's account only (students are advised not to obtain the DD in favour of the Controller of Examinations, OU).
- 7. The concerned Principal's are requested to deposit (credit) the Consolidated Examination fee amount into "Registrar, Osmania University Examination fee Fund A/c No:52198262033" in any branch of State Bank of Hyderabad and obtain a receipt from the bank and submit the same to the Examination Branch, OU along with application forms.
- 8. A penal fee of Rs.1,000/- per day shall be levied if the colleges fails to submit the application forms within the stipulated date i.e., witha late fee forms on or before 26-11-2013. No application form will be entertained afer 26-11-2013
- 9. All the candidates who are appearing the M.Ed I Semester Examinations should write the exams only in the English as per the University Orders.
- 10. The application forms will not be accepted unless the college submits clearance certificate from the Superintendent, Stores section of the Examination Branch, OU with regard to the account of 32 pages booklet stationery.
- 11. THE COLLEGES ARE REQUIRED TO ENCLOSE THE CLEARANCE CERTIFICATES ISSUED BY THE STORES SECTION OF THE EXAMINATION BRANCH AS A PROOF FOR THE UNUSED EXAMINATION STATIONERY RETURNED BY THE COLLEGE PERTAINING TO THE EXAMINATIONS CONDUCTED EARLIER.
