Application Forms submitted after 05-11-2013 will have to pay a penal fee of Rs. 1000/- per day.

1. The students are advised to enclose Xerox copies of their qualifying examination certificate copies duly attested by the College Principal concerned .
- 2.. The Principal is requested to send the **subject-wise data** without which the examination forms will not be accepted.
3. The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket.
