ii) The College Principals are requested to take consolidated Examination fee D.D amount in favor of "Registrar Palamuru University, Examination Fee Fund" in any Branch of State Bank of Hyderabad payable at SBH, Raichur road branch, Mahabubnagar and submit the same to the Examination Branch, PU along with application forms.
4. A Penal fee of **Rs. 5000/-** per day shall be levied if the college fails to submit the Examination Application form(s) within the stipulated date i.e **without late fee forms on 29-10-2012 with Late fee forms on 03-11-2012.**
5. No Examination Application form will be entertained after the due date 03-11-2012.
