GENERAL CONDITIONS TO THE PRINCIPALS:-			

- **1.** The Principals are requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fees for un-received application forms is not refundable <u>Individual demand drafts submitted by the students will not be accepted.</u>
- 2. The Principals are requested to verify and forward all the Application forms immediately along with the Name List (Nominal Roll) in prescribed proforma, subject wise data & fee particulars in duplicate.

3. i) All the students are hereby instructed to deposit Examination fee into their respective College Principal' s Accounts only (*students are advised <u>not to</u> obtain the DD in favor of the " Controller of Examinations", PU*)

ii) The College Principals are requested to take consolidated Examination fee D.D amount in favor of "Registrar Palamuru University, Examination Fee Fund" in any Branch of State Bank of Hyderabad payable at SBH, Raichur road branch, Mahabubnagar and submit the same to the Examination Branch, PU along with application forms.

- 4. A Penal fee of **Rs. 5000/-** per day shall be levied if the college fails to submit the Examination Application form(s) within the stipulated date i.e **without late fee forms on 29-10-2012 with Late fee forms on 03-11-2012.**
- 5. No Examination Application form will be entertained after the due date 03-11-2012.
