1. Applications are invited from the eligible Male Sports Persons in the given Format for recruitment of 02 Sports Persons for Liluah Workshop in the discipline mentioned below in PB-I Rs. 5200-20200/- with GP Rs. 1800/- (erstwhile Gr.'D' post) against Sports Quota open advertisement for the year 2012-13.

2. **Details of Sports Recruitment :-**

(*) However, Sports persons having **OUTSTANDING Sports achievements** and who are only **Class-VIII pass** may be considered for recruitment in **(-) Is Pay Band Rs.4440-7440/- and shall not carry any Grade Pay**. Such Sports persons will be given the regular Pay Band P.B.I of Rs. 5200-20200/- along with Gr.Pay of Rs.1800/- only on acquiring the minimum educational qualification under the recruitment rules or passing the requisite training test.

3. **Sports Discipline : (i) Football (Male) – STOPPER BACK**

(ii) Football (Male) – MIDDLE HALF

4. **Minimum Sports norms / achievement / qualification : The minimum sports norms for recruitment of sports persons in PB-1, Rs. 5000-20200/- with Grade Pay Rs. 1800/- for both team and individual events are as under :**

- i) Sports person concerned should have represented the country in any of the Championships/events, which are as under :
- (a) Commonwealth Championships. (Junior / Senior category)
 - (b) Asian Championships/Asia Cup (Junior /Senior category)
 - (c) South Asian Federations (SAF) Games (Senior category)
 - (d) USIC (World Railways) Championships (Senior category)

OR

- (ii) Should obtain at least 3rd position in Federation Cup Championships (Senior Category)
- OR
- (iii) Represented a State of equivalent unit, except in marathon and Cross Country, in Senior/ Youth/Junior National Championships.
- OR
- (iv) Should obtain at least 3rd position in senior State Championships for all units & Districts of the State.

4.(A) (*SPORTS NORMS for outstanding sports achievements for the candidates who are class-VIII pass for (-) Is Pay Band without Grade Pay.

If they represented the country in any of the Championships/Events in the category i.e. :- Olympic Games, World Cup(Junior/Senior category), World Championship (Junior/Senior category), Asian Games(senior category),Commonwealth Games(Senior Category)OR at least third(3rd) position in the Championships/events in the category mentioned in Item :- 4 above
OR at least third (3rd) position in Senior/Youth/Junior National Championships OR at least third(3rd) position in National Games organised under aegis of Indian Olympic Association OR at least third(3rd) position in All India Inter University Championship organized under the aegis of Association of Indian University OR First(1st) Position in Federation Cup Championships (Senior Category)

NB: (i). All the championships mentioned above should be conducted under the aegis of recognized International/National/State Sports Federations and also recognized by the Rly. Sports Promotion Board . (RSPB).

- (ii) Junior national Football Championship for B.C. Roy Trophy, recognized by the Rly. Sports Promotion Board (RSPB) the age group under – 19 shall be considered.
- (iii) No other tournament shall be considered except above.

5) Period of reckoning sports achievement

The sports achievements should be in the immediate previous two years and sports persons should be an active player. For this purpose, previous two financial years from the date of receipt of application or date of notification should be taken into account. Therefore, sports achievements of current year 2012-13 and previous two financial year i.e 2011-12 & 2010-11 shall be taken into account, therefore, sports achievements on or after 01.04.2010 shall only be considered for appointment. For this purpose concluding day of the Championship shall be taken into account.

6. Fee :

- i) Processing fee in the form of crossed Indian Postal Order of Rs. 40/- drawn in favour of **FA & CAO , E.Rly./Kolkata** payable at GPO/Kolkata should be attached by UR & OBC candidate with the application forms. Candidate should mention their name and address on the Indian Postal Order.
- ii) Indian Postal Order issued before the date of publication of this notification will not be accepted.
- iii) The amount of Indian Postal Order is neither refundable nor transferable nor will be kept reserved for any other purpose. Any type of suit or claim can not be filed in any court for transfer or refund of the amount of Indian Postal Order.

- iv) The candidates belonging to the following communities are exempted from payment of processing fee.
- Scheduled Castes / Scheduled Tribes
 - Minority Communities - Muslims / Christians / Sikhs / Buddhists , Zoroastrians(Parsis)
 - Economically backward class whose family income is less than Rs. 50,000/- per annum.

The economically backward class candidates have to produce income certificate on letter head in prescribed format. (Annexure – B).

NOTE : A) Certificate in proof of the above issued by the authorities authorized to issue such certificate should be enclosed by the candidates with the application form for getting exemption from paying processing fee.

B) Payment of fee in any other form will not be accepted and such applications will be treated as without fee and will be summarily rejected the candidature of the candidate.

7) Mode of Recruitment :

- The selection of candidate will be done by the competent recruitment committee and trial committee through TRIALS AND INTERVIEW.
- The candidates declared fit / suitable in TRIALS shall only be considered for the interview stage by Recruitment committee.

8. Medical Examination :

The candidate will require to be declared medically fit by Rly. Medical authority in the medical category prescribed for the post, prior to appointment after due selection.

9. How to Apply :

- Application shall be submitted in prescribed format of A4 size quality paper as per Annexure – A. The application should be in English or in Hindi language only and should be filled up clearly and neatly only in English / Hindi language by the candidate himself in INK in his own handwriting and signed in normal signature in English / Hindi.
 - Application signed in capital letters will be treated as invalid and rejected.
 - The application submitted in other than English / Hindi language will be rejected summarily.

13. Serving Candidates : Candidate serving in any Govt. Deptt. or Public Sector undertaking including Railways should apply through proper channel or should apply directly with 'NO OBJECTION' certificate from the employer to avoid delay.

14. INVALID APPLICATIONS.

The applications will be rejected on one or more of the following reasons :-

- I) The application received after the closing date due to postal delay even if it is sent by post well before the closing date.
- II) Application is not in prescribed format
- III) Application filled in a language other than English or Hindi.
- IV) Incomplete, illegible and un-signed (either in English or Hindi) or signed in Capital Letters.
- V) Application without left Thumb Impression.
- VI) In case of cutting or overwriting.
- VII) Copies of requisite certificates as detailed at para 12 are not enclosed.
- VIII) Identification marks if not indicated.
- IX) Do not possess the prescribed educational qualification & minimum sports achievement / qualification.
- X) Over aged or under aged.
- XI) Double or multiple applications submitted.
- XII) No Photographs affixed or attached.
- XIII) More than one application in single envelope.
- XIV) Application having no Indian postal order or of less amount or issued before of the date of notification (for those required to pay processing fee).
- XV) The above listing is indicative not exhaustive.

15. Conditions :

- I) The age should be reckoned as on 01.01.2013.
- II) The decision of the Rly. Administration in all matters relating to eligibility of candidates , candidature, acceptance or rejection of application, finalisation of panel etc. will be final and **no enquiry or correspondence** will be entertained on this account.
