1. NOTICE

Rail Coach Factory, Raebareli Project desires to engage full time Para-medical staff on contract basis for duration up to 30.06.2014 or up to selected candidate becomes available from RRB whichever is earlier. The place of posting will be Rail Coach Factory, Raebareli at Lalganj. The 'Walk-in interview' will be conducted at Office of the Dy. Chief Personnel Officer (Prod.), Rail Coach Factory, Project Monitoring & Execution office, Langra Phatak, Alambagh, Lucknow-226011. The provision of monthly remuneration is for full time Contract and their daily rate basis proportionate deduction from their remuneration in the event such Contract staff is absenting himself/ herself for the period exceeding from those stipulated in the contract.

2. VACANCY & ELIGIBILITY STANDARD:

2.2 Relaxation in Age limit as per provisions :

The age limit will be calculated as on 01.07.2013 for the above vacancies

2.2.1 Relaxable for 05 years to SC/ST community candidates and 03 years for OBC community candidates.

N.B: The vacancies are interchangeable and adjustable and may increase or decrease as per administrative necessity. There may be 'wait-listed/stand-by' Para-medical candidates

against the notified panel/select list who may be engaged as per necessity.

3. REMUNERATION

3.1 The following shall be monthly consolidated remuneration for full time contractual paramedical staff –

3.2 Daily rate of deduction per day from the fee for excess absence may be on pro-rata basis.

4. OTHER TERMS AND CONDITIONS

- 4.1 The selected candidates will be engaged on contract terms for a period upto 30.06.2014 subject to extension of validity of the scheme for contractual appointment of Paramedical staff by Railway Board or till the vacant posts are filled up by RRB candidates whichever is earlier.
- 4.2 The minimum working hour is 08 hours per day that may include day/night or day-cum- night as per exigency of service.
- 4.3 The rest/weekly off may be on different days not necessarily on holidays etc.
- 4.4 All the candidates should have good physical, sound mental conditions as per Railway Medical Standards and they will be subjected to medical examination as per extant railway rules and those who are found fit in the prescribed medical examination will be engaged on contract basis.
- 4.5 Eligible candidates will have to undergo preliminary professional evaluation and verification of required documents by committee of officers of RCF/RBL.
- 4.6 In case of unsatisfactory work or misconduct on the part of the personnel so engaged on contract basis, RCF/RBL reserves the right to terminate the contract at any time without assigning any reasons therefore.
- 4.7 Railway accommodation and other benefits will not be provided to the above candidates at par with the other Railway staff.
- 4.8 The candidates on contract are required to follow the dress code as per Administrative requirement at their own cost.
- 4.9 The candidates will have no prescriptive right to continue for the job given in the Notice. Their continuance on contract basis will be subject to their overall performance.
- 4.10 The candidate has no right for automatic regularization or absorption in RCF/RBL.
- 4.11 The contract will be ceased on completion of the period up to 30.06.2014 or subject to extension of validity of the scheme for contractual appointment of Paramedical staff by Railway Board automatically without issue of any notice etc, or joining of regular candidates from RRB whichever is earlier.
- 4.12 No private practice or any other employment will be permitted during the subsistence of the contract period.
- 4.13 The detailed contract agreement will have to be executed by the candidate on their successful selection.
- 4.14 During the validity of the contract, the candidates will be at liberty to terminate the contract for betterment of his/her career or any other grounds by giving prior 30 days notice to RCF/RBL.
- 4.15 The services of the candidates are also terminable before the expiry of the given period by either side after giving 30 days notice or on payment of 30 days of honorarium in lieu of the same.

- 4.16 The selected candidates will be governed by the instructions issued by the Railway Ministry/ RCF/RBL Administration for grant of leave etc.
- 4.17 The RCF/RBL Administration reserves right to deploy the candidates in any area depending upon the exigency of the service and refusal or otherwise will be treated as misconduct on the part of the candidates.
- 4.18 The selected candidates will be paid consolidated remuneration as noted in para-2 mentioned above and the candidates cannot claim any additional remuneration, allowances or other benefits during the course of contract period.
- 4.19 The candidates are personally responsible for payment of professional tax, income tax and other duties/taxes leviable by the State/Central Governments from time to time.
- 4.20 The RCF/RBL Administration reserves right to cancel, amend or otherwise modify all or any of the terms of this notification without assigning any reason(s) thereto.
