1. PH –I Year (ER-91) Regular and Backlog

The Principals of the concerned Polytechnics/institutions where regular exams are being conducted are requested to ensure for the completion of syllabus before **31-05 -2012** as per the academic calendar. A copy of the Notification is to be displayed on the Notice Board of the Institution for information of the candidates and wide publicity may be given among the students by circulating a copy of the Notification into the class rooms.

Candidates who possess 75% of attendance only should be permitted to appear for the Regular Examination and if any candidate does not put in the required percentage of attendance He/She should not be permitted to appear for the examination. However the principals are empowered to condone the shortage of attendance up to 10% after collecting the necessary amount of penalty from the candidates based on Medical Grounds only. The candidates who have paid the examination fee in the month of March-2012 (as per the earlier notification issued) need not pay now.

The principals are requested to issue the Hall Tickets to the eligible candidates one week before the examination and see that the Hall tickets will not be issued to the candidates who are detained for shortage of attendance and also the candidates who have completed the course in double the duration, even though examination fees are paid by them. A Separate list of such candidates is to be furnished to this office before **03 -06-2012** for deleting entries pertaining to such candidates from the N.R. copy of this office.
