#### **ABOUT THE COURSE:**

This course is sponsored by **Ministry of Food Processing, Government of India**. The course duration is of 2 years spread over 4 semesters covering major disciplines viz., Food Technology, Food Chemistry, Food Processing & Engineering, Food Microbiology, Food Biotechnology, Food Toxicology, Food Business Management and Project work. (15 seats alloted for technical Degree and 15 seatsalloted for science degree.)

#### I. ELIGIBILITY CONDITIONS

#### SUBJECTS OF COURSES ELIGIBLE FOR ADMISSION:

**B.Tech.** (Food Technology, Food Science & Technology, Food Science, Dairy Technology, Biotechnology or any other food related courses)

B.V.Sc.

**B.Sc.** (Agriculture, Horticulture, Food Technology, Food Science, Food Science & Nutrition, Food & Nutrition, Biotechnology, Home Science, Dairy Science, Poultry Science, and any other Food related courses)

**B.Sc.** with Chemistry as one of the subjects.

Candidates are advised to ensure that they fulfill the eligibility criteria for admission to the course he/she has applied, before appearing at the council of admissions.

#### **II. FILLING UP OF THE APPLICATION FORM**

- 1. Application form should be filled in properly and legibly by the candidate in his/her ownhandwriting.
- 2. The candidate will be held personally responsible for any incorrect entry.
- 3. Incomplete applications will be rejected summarily.
- 4. The University reserves the right to cancel the admission at any stage if particulars furnished by the candidate are found incorrect.

#### III. ADMISSION BY COUNSELING

The eligible candidates will be admitted by counseling based on the marks obtained in the qualifying exam. Candidates will be intimated by certificate of posting to the address furnished in the application, by issuing press notification or by posting the intimation in the University's website. The candidates desirous of seekingadmission have to attend the counseling in person along with all the original certificates and prescribed fee. Failure to submit T.C. and all required certificates along with fee draft / bank Challan will automatically disentitle the candidature for admission to the course. The university does not accept any responsibility for postal delay or lossduring transit of such communications.

Candidates who fail to attend counseling session for which he/she is called for will beconsidered in the subsequent phase if the seats are available in that particular categoryonly.

#### IV. RESERVATIONS
