Candidates have to submit a Xerox copy of Memorandum of marks of examination he /she appeared previously along with application form.

1. The date of commencement of Examinations and the course-wise detailed Time-Table will be notified in due course.
2. Application form(s) will not be accepted directly from any candidate or from the Principal after the due date.
3. **Students should fill the Online examination form and submit to the Principal concerned.**
4. The students should enter their name correctly in the examination form as per their Degree certificates (other than integrated course) or Inter certificate (5YIPGP). Telangana University will not be responsible for any mistakes in the candidates details.
5. The students of campus colleges have to pay the fee through B Challan (which is available in the college office) in favour of the **Registrar, TU, Examinations Accounts** payable at State Bank of India, Telangana University Branch(Code No.13804), Nizamabad – 503 322.

6. For Affiliated colleges, payment of fee must be in the form of consolidated Demand Draft (course wise) from any **Nationalised Bank** drawn in favour of **The Registrar**, Telangana University, Nizamabad.
