- 3. The students should fill the Examination Application form obtained from the respective colleges and submit to the Principal concerned.
- 4. The students should enter their name correctly in the Examination Application form as per their Degree Certificates. Telangana University will not be responsible for any mistakes in the candidates details.
- 5. The students of campus colleges have to pay the fee through B Challan (which is available in the college office) in favour of the Registrar, TU, Examinations Account payable at State Bank of India, Telangana University Branch(Code No.13804), Nizamabad - 503 322.
- 6. Fee Paid once cannot be refunded or adjusted for any future examination.
- 7. Application forms should be scrutinized and signed by the Principal/Academic Coordinator of the college in accordance with the guidelines and instructions issued and should be tied separately in chronological order.
