(I)The recruitment for the post of Probationary Clerks is on State-wise / Union territory-wise basis. Candidates can apply for Probationary Clerk post in ONE STATE / UNION TERRITORY ONLY and should have appeared for the CWE, from a centre allotted for that particular State / Union Territory in IBPS CWE-CLERK 2011. On selection, candidates will be placed anywhere in that state / union territory depending up on Bank's requirement. Candidates belonging to reserved categories, for which no post has been announced, are free to apply against the Un-Reserved Posts, provided they fulfill the eligibility criteria mentioned.

- (ii) Candidates should be able to read, write and speak English.
- (iii) Candidates should possess proficiency in the official language of the State/ UT (ability to read, write and speak local/State language) in which they have appeared for the Common Written Examination (CWE-CLERK 2011) and in which they have qualified

The reservation for Persons with disabilities (PWD) and Ex-Servicemen (XSM) is on horizontal basis. The selected candidates will be placed in the appropriate category (viz., SC, ST, OBC, GEN etc.) to which they belong.

Reservations are followed strictly as per Government Guidelines. The number of vacancies and also the number of reserved vacancies is provisional and may vary according to actual requirement of the Bank.

In case of non-availability of reserved candidates in **Persons with disabilities** (PWD) category, Bank reserves its right to inter–change these sub-categories as per Government Directives.

It is clarified that it may not be possible to employ Persons With Disabilities in all Offices/Branches of the Bank and they will have to work in the post identified by the Bank as suitable for them.

### Abbreviations stand for:

SC - Scheduled Caste; ST - Scheduled Tribe; OBC - Other Backward Classes; GEN (General-Unreserved); XSM - Ex-Serviceman; PWD - Person With Disability OC - Orthopaedically Challenged, HI - Hearing Impaired, VC - Visually Challenged.

### Definition of Ex-Servicemen (XSM):

- I. Ex-Servicemen(XSM): Only those candidates shall be treated as Ex-servicemen who fulfill the revised definition as laid down in Government of India, Ministry of Home Affairs, Department of Personnel & Administrative Reforms Notification No.36034/5/85 Estt. (SCT) dated 27.01.1986 as amended from time to time.
- ii. Disabled Ex-Servicemen(DISXS): Ex-servicemen who while serving in Armed Forces of the union were disabled in operation against the enemy or in disturbed areas shall be treated as DISXS.
- iii. Dependents of Ex-Servicemen Killed In Action (DXS): Servicemen killed in the following operations would be deemed to have been killed in action attributable to military service (a) war (b) war like operations or Border skirmishes either with Pakistan on cease fire line or any other country (c) fighting against armed hostiles in a counter insurgency environment viz

Nagaland, Mirzoram, etc. (d) serving with peace keeping mission abroad (e) laying or clearance of mines including enemy mines as also mine sweeping operation between one month before and three months after conclusion of an operation (f) frost bite during actual operations or during the period specified by the Government (g) dealing with agitating para-military forces personnel (h) IPKF Personnel killed during the operations in Sri Lanka.

## The definitions of VC, HI, OC are as prescribed in "The Persons with Disabilities (Equal opportunities protection of Rights & full participation) Act 1995".

- 1. Locomotor Disability or Cerebral Palsy (OC) Persons who have a minimum of 40% of physical defect or deformity which causes an interference with the normal functioning of the bones, muscles and joints.
- 2. Hearing Impairment (HI) Those in whom the sense of hearing is non-functional for ordinary purposes of life, i.e., those who do not hear, understand sounds at all, even with amplified speech. The cases included in this category will be those having hearing loss of more than 90 decibels in the better ear (profound impairment) or total loss of hearing in both ears.
- 3. Visually Challenged (VC) (Blindness or Low Vision) Refers to a person who suffers from any of the following conditions:
- a) Total absence of sight.
- b) Visual acuity not exceeding 6/60 or 20/200 (Snellen) in the better eye with correcting lenses, or
- c) Limitation of the field of vision subtending an angle of 20 degree or worse and so certified by a Medical Board appointed by the State Government

Candidates belonging to reserved category including Persons With Disability & Ex-Servicemen, for which no reservation has been announced, are free to apply for vacancies announced for unreserved category, however they must fulfill all the eligibility conditions of unreserved Category.

#### Note:

- a) An Ex-Serviceman who has once joined a government job on the civil side after availing the benefits given to him as an Ex-Serviceman for his re-employment, including a job in Public Sector Undertaking, ceases to enjoy ex-serviceman status for further employment.
- b) Relaxation in upper age limit available to SC/ST/OBC candidates is allowed on cumulative basis with only one of the remaining categories for which age relaxation is permitted as mentioned above.
- c) All persons eligible for age relaxation under Serial no. (5) above must produce the domicile certificate at the time of interview from the District Magistrate in the Kashmir Division within whose jurisdiction he/she had ordinarily resided or any other authority designated in this regard by Govt. of J & K to the effect that the candidate had ordinarily been domiciled in the Kashmir Division of the State of J & K during 1stJanuary, 1980 and the 31st December, 1989.
- d) All persons eligible for age relaxation under serial no. (7) above must possess a certificate from the Competent Authority to the effect that their father/mother/family member died in the 1984 riots.
- e) Candidates seeking other age relaxation/s will be required to submit copies of necessary certificate(s) at the time of interview.

  5. ELIGIBILITY CRITERIA:

### 5.1 NATIONALITY/CITIZENSHIP:

A candidate must be either (i) a citizen of India or (ii) a subject of Nepal or (iii) a subject of Bhutan or (iv) a Tibetan Refugee who came over to India before 1st Jan. 1962 with the intention of permanently settling in India or (v) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India, provided that a candidate belonging to categories (ii), (iii), (iv) & (v) above shall be a person in whose favour a certificate of eligibility has been issued by the Govt. of India. A candidate in whose case a certificate of eligibility is necessary may be admitted to the examination/interview conducted by the IBPS/Bank but on final selection the offer of appointment may be given only after the necessary eligibility certificate has been issued to him by the Govt. of India.

### 5.2 EDUCATIONAL QUALIFICATIONS as on 01.08.2011:

### Candidates must possess the requisite qualifications as on 01.08.2011.

A pass with 60% marks in the aggregate in Matriculation/SSC (old pattern)/SSLC/10th Std. Examination of 10+2+3 pattern or equivalent. For SC/ST/OBC/PWD/XSM candidates, a pass in the aggregate in Matriculation/SSC (old pattern)/SSLC/10th Std. Examination of 10+2+3 pattern or equivalent

OR

A pass with 50% marks in HSC examination of 10+2 (10+2+3 pattern)/ 11th Std. of 11+1+3) pattern or Intermediate/ Pre-University or any equivalent examination/ Diploma in Banking recognized by Central/ State Government or U.T. administration. For SC/ST/OBC/PWD/XSM candidates, a pass in HSC examination of 10+2 (10+2+3 pattern)/ 11th Std. of (11+1+3) pattern or Intermediate/ Pre-University or any equivalent examination/ Diploma in Banking recognized by Central/ State Government or U.T. administration.

OR

Degree in any discipline from a recognized University or any equivalent qualification recognized as such by the Central Government

Candidates with higher qualification will have added advantage. Preference will be given to computer literate (proficient in MS Office Basic Applications).

Degrees obtained from the recognized Universities/Institutes recognized by the Govt. of India only will be considered. Candidates must specifically indicate the class / division and percentage of marks obtained calculated to the nearest two decimals in the relevant column of the online application. Where no percentage of marks is awarded by the University, but only Cumulative Grade Point Average (CGPA)/ Overall Grade Point Average (OGPA) is awarded, the same should be converted into percentage, besides indicating the CGPA/OGPA in the online application.

#### 6. SELECTION PROCEDURE:

- a. Depending upon the number of vacancies, only those candidates (with the above minimum score in the CWE conducted by IBPS and possess a valid score card issued by IBPS), who have applied to our Bank's vacancy notification and rank sufficiently high in the order of merit based on the TWS and as decided by the Bank shall be called for interview.
- $b. Mere\ eligibility/obtention\ of\ specified\ marks\ in\ TWS\ shall\ not\ vest\ any\ right\ in\ a\ candidate\ for\ being\ called\ for\ interview.$

#### 6.1 Interview:

a) The interview shall be conducted to assess the personality traits having bearing on interpersonal competence, emotional stability, adaptability, courtesy, self confidence & temperament, positive attitude towards work/ people and communication skills etc. Maximum marks for interview shall be 100 with minimum qualifying marks of 40% (35% in case of Reserved Category candidates as per GOI guidelines.)

#### 6.2 Final Selection:

Final selection will be on the basis of the merit ranking reckoned after adding the marks obtained in the **Total Weighted Score in the CWE and Interview.**

A rank/merit list of candidates in the descending order of merit, category wise, based on the total marks obtained by them in the above two criteria, shall be prepared state wise and the final selection shall be in the descending order of merit and as per GOI guidalines.

### 8. IDENTITY VERIFICATION:

While appearing for the Interview, the candidate should produce his/her photo identity such as PAN Card / Passport / Driving License / Voters ID Card / Bank Pass Book with Photograph / Photo embossed Credit Card for verification. If the identity of the candidate is in doubt, the candidate will not be allowed for Interview.

### 9. GENERAL INSTRUCTIONS:

a) Educational Qualifications: The qualifications prescribed for the post are the minimum. Candidates must possess the

## qualifications as on **01.08.2011**. b) Probation Period: Six months.

- c) Before applying for the post, the candidate should ensure that he/she fulfils the eligibility criteria and other norms mentioned in this advertisement. Decision of the Bank in all matters regarding eligibility of the candidate, the stages at which such scrutiny of eligibility is to be undertaken, the documents to be produced for the purpose of the conduct of examination, interview, selection and any other matter relating to recruitment will be final and binding on the candidate. The Bank in this behalf shall NOT entertain any correspondence or personal enquiries. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and/or that he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of this/these shortcoming/s is/are detected even after appointment, his/her services are liable to be terminated.
- d) The online application once made will not be allowed to be withdrawn and the fee once paid will not be refunded on any
- account nor would this fee be held in reserve for future examination/selection.

  e) Applications which are incomplete in any respect will be rejected and the fee will be forfeited.
- f) Calling/admission to the interview is purely provisional without verification of age/qualification/category etc. of the candidates. Mere receipt of call letter for interview does not imply that the Bank is satisfied about the candidate's eligibility. Candidates should ensure their eligibility before applying/attending the interview. Bank reserves the right to reject ineligible candidates' applications at any stage and the fee paid by ineligible candidates shall be forfeited
- g) The short listed candidates are required to submit photocopy of all the documents pertaining to Age, Qualification, Experience, Caste etc at the time of interview. These documents will be verified with originals at the time of interview. If any candidate is found ineligible while verifying the documents, he / she shall not be allowed to take up interview.
- h) Candidates belonging to SC/ST/OBC/Persons with Disabilities categories should keep ready an attested copy of certificate issued by competent authority in the prescribed format as stipulated by Government of India. In case of candidates belonging to OBC category, certificate should specifically contain a clause that the candidate does not belong to creamy layer section excluded from the benefits of reservation for Other Backward Classes in Civil post & services under Government of India. OBC caste certificate should not be more than one year old.

(d) Sub-divisional Officer of the area where the candidate and/or his family normally resides.

For Persons with disability (PWD): Authorised certifying authority will be Medical Board at the District level. The Medical Board will consist of Chief Medical Officer, Sub-Divisional Medical Officer in the District and an Orthopaedic Surgeon.

- i) An Ex-serviceman candidate has to produce a copy of the discharge Certificate / pension payment order and documentary proof of rank last / presently held (substantive as well as acting) at the time of interview. <u>Those who are still in defence</u> service should submit a certificate from a competent authority that they will be relieved from defence services, on or before 30.07.2013.
- j) The candidates will have to appear for the Interview at the allotted centres at their own expenses. However, eligible outstation SC/ST & PWD candidates attending the interview will be reimbursed to & fro Second Class Rail/Bus fare by the shortest route on production of evidence of travel. Fare will not be reimbursed to candidates belonging to other categories appearing for interview and those SC/ST/PWD candidates who are already employed with the Government of India, PSUs /PSBs/ State Governments.
- k) Candidates should be willing to serve in any of the branches in the State/Union terrritory for which he/she has applied. However all the clerical employees are governed by the Service conditions applicable to them and the Bank reserves the right to transfer the candidates to any of its branches/offices on administrative exigencies.
- I) Candidates serving in Government/Public sector undertaking (including banks) are required to produce a "No Objection Certificate" from their employer at the time of Interview, in the absence of which their candidature may not be considered. In order to ensure that the applications are made well in time, the candidates are advised to remit the fee and apply online well before the closing date.
