**AGE:** Should have completed minimum 14 (fourteen) years of age as on 01.10.2011.

The applications now invited will be utilised for future training placements also, if necessary.

**RESERVATION:** The reservation of training placements for the Scheduled Castes, Scheduled Tribes and Other Backward Classes is in a ratio of 1:8, 1:20 and 1: 4 respectively, on the basis of total number of placements in terms of Apprentices Act, 1961.

**PAYMENT OF STIPEND TO APPRENTICES:**

- a) During the first year of training : Rs. 1490/- per month.
- b) During the second year of training : Rs. 1700/- per month.
- c) During the third year of training : Rs. 1970/- per month.

**MODE AND CRITERIA OF ENGAGEMENT OF APPRENTICES:**

- a) Engagement of Trade Apprentices will be made purely on merit, on the basis of aggregate marks obtained by the candidate in ITI.
- b) Preference will be given to the children of Visakhapatnam Port Trust employees: in the ratio of 4:1:1 i.e. 4 for VPT, 1 for CHD and 1 for outsiders. Again out of the ratio of 4 for the children of port employees the sub-ratio of 2:1:1 will be followed to the children of deceased employees/medically invalidated & superannuated employees/serving employees respectively.
- c) Those who are short-listed basing on merit of marks secured in the qualifying exams will only be called for certificates verification.
- d) The trades will be allotted to the candidates at the discretion of the Head of the Department.

SUBMISSION OF APPLICATIONS:

- a) The filled in applications in the prescribed proforma along with necessary certificates duly attested by a Gazetted Officer shall be submitted to the Chief Mechanical Engineer, Visakhapatnam Port Trust, Visakhapatnam-530 035 either by post or in person on or before **20.01.2012** by 5.00 p.m.
- b) Incomplete applications or applications submitted without attested copies of relevant certificates will not be considered.
- c) The SC/ST/OBC candidates should furnish the **latest prescribed community certificate** signed by the competent authority not below the rank of M.R.O.
