- 2) To scrutinize carefully the records of the candidates who had been awarded more than 80% in Practical's.
- 3) Compare both practical marks and record marks.
- 4) Check the practical marks with the records and count the number of records and verify the absentee Reg. No.
- 5) Check all the records whether they have been written by the candidates only. If the hand writing varies, a fine of Rs. 2500/- per candidate should be levied.
- 6) Check the Syllabus written in Lesson Plans that are allotted to the month (as per schedule) which students have gone for Internship programme.
- 7) **All the concerned Lecturers as per the staff approved by the University of respective subjects should attend at the time of moderation. If they fail to attend a fine of Rs. 5000/- may be levied.**
- 8) Principals should bring the letters from DEO for Internship Programme.(schedule)

- 9) Check all the records are signed by the Head Master.
- 10) Check the signature of the Principal in all records manual / Facsimile.
- 11) Check first four pages (All the Certificates, Self Declaration, College Certificate, School Certificate)
- 12) Check the Index with relevant dates, with page no's.
- 13) Check all the 20 Lessons are there or not in the lesson plan.
- 14) S.A.T Record should be attached with Answer Sheets.
- 15) Check the Micro Teaching measurements.
- 16) Reports of the students should be attested by the Head Masters.
- 17) Case study records should have the photos of the students with their signatures.
- 18) It is proposed to improve the pattern of moderation cum record verification for B.Ed Practical Examination by including one External Examiner in all subjects from the panel of Examiners submitted. It is also proposed to have one External Examiner and two Internal Examiner from the University approved list in all subjects to ensure fairness and transparency.
- 19) If a candidate fails to submit records upto 5, a fine of Rs.2,000/-, 6 to 10 Rs.5,000/- if more than 11 to 19 Rs. 7,000/- may be levied and they must submit their records within a month.
- 20) Any other instructions which the Chairman, Board of Studies / Controller of Examinations / Director (P.G & Professional Courses) deem fit to be followed.
- 21) TA & DA, etc. may be paid as per the University rules. Remuneration for Chairman per session (8 A.M. to 1 P.M.) Ist session & (2 P.M. to 6 P.M.) IInd session Rs.400/- per session and for Member per session is Rs.250/- shall be paid.
- 22) The Moderation Board may be conducted from 31.10.2012 (Wednesday) onwards (daily two sessions).
- 23) The expenditure may be debited to the Budget Head Block Grant Section Examination Account, TA/DA for the year 2012-2013.
