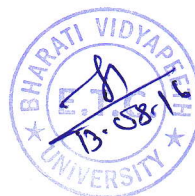

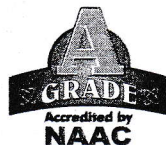

- 2) The students who are given admission will be required to pay the annual fee for the Year **2016-2017**.

- 3) **You will be required to pay the entire amount of fees at the time of admission by demand draft drawn on any nationalized bank or Bharati Sahakari Bank payable at Pune in favour of "Registrar, Bharati Vidyapeeth University, Pune".** You should please note that you will not be given any extension in time for the payment of fees. If you fail to pay the full amount of fees at the time of counseling, you will forfeit your claim on the seat offered to you and same will be allotted to the next candidate in the list and no complaint in this regard will be entertained.
- 4) **Hostel fees:** If you desire to have hostel accommodation, limited hostel accommodation is available on the campus both for boys and girls. The same will be allotted on the first come first served basis. The hostel room rent and other charges will have to be paid at the time of admission only.

- 6) Failure to remain present personally or through an authorized representative, and/or failure to present all the necessary documents in original at the time of counseling and/or failure to make payment of the total amount of annual fees for whatsoever reason will ultimately result in an instantaneous and permanent forfeiture of your claim on any seat for admission.
- 7) The academic session of **MD/MS/DIPLOMA (Ayurved)** courses will start on **17th August 2016**. All the students who are given provisional admissions to the respective courses will have to remain present on that day.
