4	Registration Fee:- Rs.3050/- for OC/BC & Rs.2750/- for SC/ST to be remitted in the form of e-challan in any branch of State Bank of India by following instructions laid down in Prospectus for admission into the above courses.											
5	Verification Fee:- Rs. 1000/- towards verification of Degree for the candidates who studied BAMS/BHMS/BUMS Courses from out side the state of Andhra Pradesh.											
5	Submission of filled-in online application form: The candidates should submit print out of the filled-in online application form along with the copies of the required certificates attested by Gazetted Officer and SBI e-challan (University copy) on or before 18-10-2014 up to 5.00 p.m. either by post or in person to The Convener, Post Graduate Committee AYUSH Courses, Dr. NTR University of Health Sciences, A.P., Vijayawada – 520 008. The candidate should clearly superscribe on the cover containing online application form as " Application for M.D (Ayurveda) Entrance Test-2014 " or " Application for M.D(Homoeo) Entrance Test -2014 " or " Application for M.D(Unani) Entrance Test -2014 " whichever is applicable.
