**Last++** : Means those Muslim Minority candidates who have secured in group subjects of Intermediate (10+2) or its equivalent examinations (45% and above for OC and 40% and above for BC) are also eligible for attending the counseling, after exhausting the Qualified and Eligible Muslim Minority Candidates.

Candidates should produce all certificates in ORIGINAL viz (1)EAMCET-2014 Rank card & Hall ticket (2)Memorandum of Marks of Intermediate or its equivalent (3)Memorandum of Marks of SSC or its equivalent (4)Study Certificates from 7<sup>th</sup> Class to Intermediate (5)Residence certificate for preceding seven years of the qualifying examination i.e. Intermediate in respect of candidates who had private study without any institutionalized education (6)Residence Certificate of Father or Mother for a period of 10 years in Telangana / A.P. excluding the period of their employment outside A.P. from M.R.O. in case of Non local candidates. (7) Muslim Minority students shall be eligible for reimbursement of Tuition Fee subject to the eligibility rules to be stipulated in due course by the Governments of Telangana and Andhra Pradesh.

**Fee Particulars:** Candidates will have to pay non refundable fee of Rs.300/- and Rs.600/- towards registration and counseling respectively, and the candidate have to pay the Tuition Fee as prescribed by the Government if, any. Fee shall be remitted as Demand Draft drawn in favour of “**Convener, EAMCET-AC-SW-II-2014 Admissions**” payable at Hyderabad or in cash at the bank counter available at the venue. Fee shall be paid in full at the time of counseling and no part payment will be accepted.

Candidates are informed that they should satisfy the admission rules prescribed by the respective universities and should be prepared to pay the Tuition Fee as applicable. The above fee structure is subjected to any enhancement by the Govt. More number of candidates are called for counseling than the seats available. Hence mere attending the counseling does not guarantee a seat.

**Note:**

1. This notification is itself a call for counseling. No separate call letters shall be sent to individual candidates. Candidates may have to stay a day extra, if required.
2. If fee is not reimbursed, then the student has to pay Tuition Fees in full at college.
3. Muslim minority candidates who have already taken a seat through Convener EAMCET-2014 (SW.I) admissions are permitted to slide to a college of their choice in SW-II & vice versa along with original receipt of certificates and paying a (Non Refundable) amount of Rs.300/- & Rs.600/- towards Registration & Counseling fee respectively.
4. Last date for cancellation of admission taken through SW-II is 16.10.2014.
5. Last date for the allotted candidates of convener, EAMCET-SW-II to report to their respective college is 17.10.2014.
