एमबीबीएस एवं बीडीएस पाठ्यक्रमों में AIPMT-2016 के माध्यम से
शैक्षणिक सत्र-2016-17 के लिए प्रवेश हेतु सूचना ।

निदेशक चिकित्सा शिक्षा एवं अनुसंधान, हिमाचल प्रदेश से प्राप्त निर्देशों के अनुसार सभी सम्बन्धित अभ्यर्थियों को सूचित किया जाता है कि एमबीबीएस एवं बीडीएस पाठ्यक्रमों में हिमाचल प्रदेश में स्थित राजकीय आयुर्विज्ञान/दन्त महाविद्यालयों तथा निजी आयुर्विज्ञान/दन्त महाविद्यालयों में प्रवेश शैक्षणिक सत्र-2016-17 के लिए अखिल भारतीय स्तर की प्रवेश परीक्षा AIPMT-2016 के माध्यम से किया जायेगा, जो कि केन्द्रीय माध्यमिक शिक्षा बोर्ड, दिल्ली द्वारा दिनांक 1 मई 2016 (रविवार) को आयोजित की जा रही हैं जिसके लिए आवेदन करने की ऑनलाईन प्रक्रिया केन्द्रीय माध्यमिक शिक्षा बोर्ड, दिल्ली की वेबसाइट www.aipmt.nic.in पर दिनांक 15 दिसम्बर 2015 से शुरू हो चुकी है जिसकी अन्तिम तिथि 12 जनवरी 2016 है । एक हजार चार सौ रुपये के अतिरिक्त विलम्ब शुल्क सहित ऑनलाईन आवेदन की अन्तिम तिथि 10 फरवरी, 2016 है । अधिक जानकारी के लिए सीबीएसई की वेबसाइट www.aipmt.nic.in पर देखें । इसके दृष्टिगत एमबीबीएस एवं बीडीएस पाठ्यक्रमों में प्रवेश हेतु विश्वविद्यालय द्वारा अलग से कोई प्रवेश परीक्षा आयोजित नहीं की जाएगी । केन्द्रीय माध्यमिक शिक्षा बोर्ड दिल्ली द्वारा हिमाचल प्रदेश राज्य कोटे की सीटों के लिए उक्त प्रवेश परीक्षा की मैरिट जारी की जाएगी उसके आधार पर विश्वविद्यालय द्वारा अलग से प्रौस्पैक्टस जारी कर एमबीबीएस एवं बीडीएस पाठ्यक्रमों में हिमाचल प्रदेश में स्थित राजकीय आयुर्विज्ञान महाविद्यालयों/दन्त महाविद्यालयों तथा निजी दन्त महाविद्यालयों में राज्य एवं प्रबन्धकीय कोटे के अन्तर्गत प्रवेश हेतु उक्त प्रौस्पैक्टस में दी गई पात्रता शर्तों को पूर्ण करने वाले अभ्यर्थियों से निर्धारित तिथि के अन्दर उचित समय पर ऑनलाईन आवेदन-पत्र आमन्त्रित किए जाएंगे जिसके लिए सूचना निदेशक चिकित्सा शिक्षा एवं अनुसंधान, हिमाचल प्रदेश की वेबसाइट www.hp.gov.in/hpdmer तथा विश्वविद्यालय की वेबसाइट www.hpuniv.in पर दी जाएगी । उक्त पाठ्यक्रमों में राज्य कोटे की सीटों के अन्तर्गत प्रवेश हेतु अभ्यर्थी का नाम हिमाचल राज्य की AIPMT-2016 की मैरिट सूची में अवश्य शामिल होना चाहिए, अन्यथा अभ्यर्थी के नाम पर प्रवेश हेतु विचार नहीं किया जाएगा । इसलिए अभ्यर्थियों को सलाह दी जाती है कि वे सावधानीपूर्वक ऑनलाईन आवेदन करते समय **H.P. Notice for Eligibility criteria for seeking admission to MBBS/BDS courses in
Medical/Dental Colleges in the State of Himachal Pradesh through AIPMT-2016

ELIGIBILITY AND QUALIFICATIONS

(A) For State Quota Seats :

1. Children of Bonafide Himachali/Domicile/Himachal Govt. employees and employees of Autonomous Bodies wholly or partially financed by the Himachal Pradesh Government who will qualify the AIPMT-2016 are only eligible to apply for admission to MBBS/BDS courses through counselling on the basis of state merit ranking of AIPMT-2016 in Government Medical/Dental Colleges including 50% State Quota seats in Private un-aided Medical/Dental Colleges situated in Himachal Pradesh. They should have passed atleast two exams out of the following examinations from the recognized schools or colleges situated in the State of Himachal Pradesh and affiliated to ICSE/CBSE/H.P. Board of School Education or equivalent Boards/Universities established by law in India.

- (a) Middle or equivalent
- (b) Matric or equivalent
- (c) 10+1 or equivalent
- (d) 10+2 or equivalent

2. The Bonafide Himachali students who are admitted to Navodya Schools situated in Himachal Pradesh and who have passed matric or +2 examinations under the exchange programme from other Navodya Schools in the Country shall also be eligible for admission to the above courses.

3. Following categories of candidates are exempted from the condition of passing the examinations from recognized schools situated within Himachal Pradesh and affiliated to ICSE/CBSE/HP Board of school Education, provided that the candidates of these categories should be Bonafide Himachali /Domicile and their father/mother are living outside Himachal Pradesh on account of their service/posting /private occupation. In such cases, non-schooling in Himachal Pradesh shall not debar them from competing against any of the seats whether reserved or otherwise (except backward area seats):-

- (i) Children of Defence Personnel/Ex-Servicemen
- (ii) Children of serving /retired employees of Central Government/U.T./Other State Governments and Children of employees of the Autonomous Organizations/Semi Government Bodies of Central Government/U.T./Other State Governments.
- (iii) Children of employees of Himachal Pradesh Government/H.P. Govt. Undertaking/Autonomous Bodies wholly owned by H.P. Government.
- (iv) Children of employees of Private Sector / Private occupation.

Note : (1) The candidates exempted for passing two examinations from the schools situated in Himachal Pradesh under the category (iv) as mentioned above, should have passed their schooling from the schools situated in the place /station where their father/mother are residing.

(2) The candidates claiming exemption for passing two examinations from H.P School(s) under the categories as mentioned in sub-clauses (ii) & (iv) above of clause 3 shall also submit a certificate on the prescribed format as given in the prospectus at **Appendix A-11, A-12, A- 13 & A-14 with the application form in original**, as applicable.

(3) Candidate while applying for AIPMT-2016 (online) does not opt State of Himachal Pradesh, their candidature shall not be considered for admission to MBBS/BDS course under State Quota seats of Himachal Pradesh irrespective of fulfilling the aforesaid eligibility criteria.

(B) For Management Quota Seats

The Management Quota Seats in Private un-aided Medical/Dental Colleges in the State of Himachal Pradesh will be filled up from the qualified candidates of AIPMT-2016 for which there will be no Bonafide Himachali/Domicile and schooling conditions under this quota. The Himachali and Non-Himachali interested candidates will be considered for admission to MBBS/BDS course through counselling in order of merit subject to fulfillment of minimum educational qualification and age etc. as prescribed in the prospectus.

Note: Candidates who do not fulfil the eligibility criteria prescribed for State Quota Seats, will be considered only for Management Quota seats, if otherwise they are interested.

4. Educational Qualifications and Other Conditions: Candidates should have passed in any one of the following qualifying examination at the time of first round of counselling:-

- a) The Higher/Senior Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher/Senior Secondary Examination after a period of 12 years study, the last two years of such study comprising of Physics, Chemistry, Biology/Bio-technology(which shall include practical tests in these subjects) and Mathematics or any other elective subject with English at a level not less than the core course for English as prescribed by the National Council of Educational Research and Training after introduction of the 10+2+3 educational structure as recommended by the National Committee on Education.

OR

B.Sc. Examination of an Indian University provided that he/she has passed the B.Sc. Examination with not less than two of the subjects Physics, Chemistry, Biology(Botany, Zoology)/Bio-technology and further that he/she has passed the earlier qualifying examination with Physics, Chemistry, Biology and English.

OR

Any other examinations which in scope and standard (Last 2 years of 10+2 study comprising of Physics, Chemistry and Biology/Bio-technology; Which shall include practical test in these subjects) is found to be equivalent to the intermediate Science Examination of an Indian University/Board, taking Physics, Chemistry and Biology/Bio-technology including practical tests in each of these subjects and English.

Provided that to be eligible for competitive entrance examination, candidate must have passed any of the qualifying examinations as enumerated above or appearing in the qualifying examination in 2016. Provided also that to be eligible for competitive entrance test the candidate must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology/Bio-technology at the qualifying examination as mentioned in clause (2) of regulation 4 on Graduate Medical Education 1997 and in addition must have come in the merit list of AIPMT-2016 for admission to MBBS/BDS courses subject to fulfilment of eligibility criteria as laid down in the prospectus.


In respect of the candidates belonging to Scheduled Castes, Scheduled Tribes or Other Backward Classes, the marks obtained in Physics, Chemistry and Biology/Bio-technology taken together in qualifying examination shall be 40% marks instead of 50% marks for General candidates. Further, for persons with locomotory disability of lower limbs, minimum of 45% marks for Gen-PH and 40% marks for SC-PH/ST-PH/OBC-PH are required.

Provided further that the students studied abroad seeking admission into Medical/Dental Colleges in India must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English upto the 12 standard level with 50% marks as mentioned above and their equivalency shall be determined as per regulations of the Medical Council of India by the Association of Indian Universities, New Delhi.

Note: Marks obtained in Mathematics are not to be considered for admission to MBBS/BDS courses.

AGE:The candidate should have already completed or should complete the age of 17 years and must completed 25 years of age on 31st December of the year of his/her admission to the 1st year MBBS/BDS course. The Applications, of candidates who do not fulfil the age requirements will be summarily rejected. Date of Birth as recorded in the Matriculation/Higher Secondary Certificate/Indian School Certificate will only be valid. The candidate must born on or between 1.1.1992 to 1.1.2000(for all categories).
