Applications are invited in the prescribed proforma from the eligible candidates for enrolment to Ph.D. (Full time and Part time) programmes in various disciplines of the University. The University has identified the vacancies of Ph.D. Programmes in various disciplines in accordance with the Govt. Reservation Policy appended as **Annexure -I** The candidates should go through the **Annexure – I** carefully and apply accordingly for the available vacancy along with all the supporting documents

The registration shall be made as per the Ph.D. Regulation governing the award of the Degree of Doctor of Philosophy (Ph.D) of 2015 of this University. The provisional Registration process is through an Entrance Test followed by statutory procedures prescribed in the Ph.D. Regulations. Mere qualifying in the Entrance Test does not guarantee the Provisional Registration.

2. The prescribed Application Form can be obtained in person or through Post (self addressed envelope with Stamp of Rs.50/- to be sent alongwith Demand Draft) from the office of the “Deputy Registrar , Academic Section, Kuvempu University, Jnana Sahyadri, Shankaraghatta – 577 451”, on payment of the prescribed fee of Rs.960/- (in respect of SC/ST/Cat-1 Rs.720/- only - with a copy of proof of caste) through a Demand Draft drawn in favour of the “Finance Officer, Kuvempu University , Shankaraghatta” payable at SBM/SBI, Shankaraghatta – 577 451. **Applications will be issued from 14-12-2015. The last date for submission of the application shall be 28-12-2015.** The application shall be sent to the Chairperson of the concerned Department at Shankaraghatta. alongwith the required documents.

3. **The Application Forms can also be downloaded from the website www.kuvempu.ac.in** and shall be submitted to the Chairperson of the concerned Post Graduate Department alongwith the required documents and also with a Demand Draft of Rs. 960-00 (in respect of SC/ST/Cat-1 Rs.720/- only - with a copy of proof of caste) drawn in favour of the “Finance officer, Kuvempu University , Shankaraghatta”.

A. Conditions of Eligibility :

Candidates who have secured at least 55% of aggregate marks (50% for SC/ST/ Cat-1 candidates) or equivalent grade under grading system, in their Master’s Degree or equivalent examination from the recognized Universities/Institutions

B. The following are eligible for EXEMPTION from the ENTRANCE TEST:

- Foreign and sponsored candidates,
- Teachers on FIP/QIP,
- Candidates who have passed the M.Phil/NET for Research fellowship (UGC/UGC-CSIR National Eligibility Test for Junior Research Fellowship) GATE/GRE, and
- JRF and Project Fellows (who are selected through a defined process in any Research Project sanctioned and funded to any teacher of the concerned P.G. Department by UGC or by any agency of the State or Central Government or that of Foreign countries),
- those who have completed the Eligibility Test for Lectureship through the accredited State or National Agency.
