Fresh candidates appearing for I-Semester shall enclose Xerox copies of their Degree Certificates and marks memo of the qualifying examinations duly attested by the Principal of College concerned. (Provisional Certificate /Xerox copies of such qualifying examinations for which convocation is over, will not be accepted). Candidates from other Universities should enclose their Original Migration Certificate together with a fee of Rs. 150/- in addition to the examination fee.
- 6. (i) The Principals are requested to forward all the examination application forms duly attested on or before 24.11.2014 without fail. Forms received after the due date will be levied a penal fee of Rs. 1000/- per day.
  - (ii) Submit two soft copies (2 CDs) of I-Semester and three (3) hard copies of the candidates.
  - (iii) Candidates will be held responsible for any mistake committed while filling the examination application form regarding paper titles (Theory & Practical). In case of any mistake Rs. 500/- will be levied as fine for rectification.
